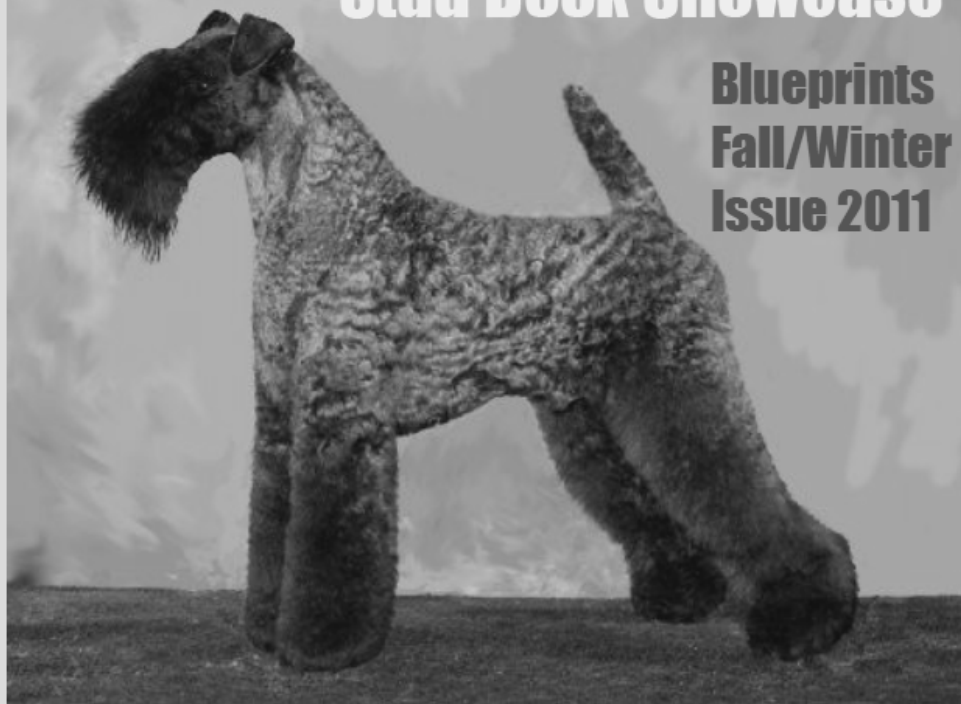

Could Your Kerry “Find It?”

A scattering of cardboard boxes, similar in size, lay on the training room floor. To the casual observer, it looks like a jumbled mess. But to the handler and the Kerry by her side, tail wagging wildly and nose twitching, it is another chance to play the game: Nose Work!

K9 Nose Work, the newest sport for dogs, is sweeping the nation. Started on the West Coast in 2006 by three very experienced professional trainers (Ron Gaunt, Amy Herot and Jill Marie O'Brien) who, themselves, trained and handled dogs to detect narcotics and explosives, this sport is geared toward companion dogs, young and old, mixed breeds and purebred, as well as dogs that are shy or reactive. It is a great confidence builder, while helping to calm energetic dogs. The objective of Nose Work is to have the dog find a particular scent hidden in a location and then indicate (alert) that find to the handler. While not physically demanding for dog or handler, it does provide a high degree of mental stimulation for the dog and lets them really put their superior sense of smell to work. In addition, it allows the dog to turn the tables and teach the handler to observe the dog's responses and trust the dog's judgment when it indicates that the odor has been found.

Unlike traditional classes, which may be stressful or overstimulating to some dogs, dogs are worked one at a time in the search area, allowing each dog to focus on the task at hand and permitting the handler to focus on his/her dog. Because they are worked individually, dogs that are reactive to other dogs or people can participate in this sport without fear of further reinforcing their reactivity. Behaviors that are not be looked upon favorably in an obedience class, such as pulling or not focusing on the handler, are actually encouraged and desired in a Nose Work class. Dogs that are eager to hunt and show that eagerness are applauded!

A typical Intro to Nose Work class begins by teaching the dog what the game is. A few aromatic pieces of food are hidden in one of 6 boxes stretched out in a line, with the cover of the boxes typically open. As the dog travels down the line of boxes, sniffing and checking each one, it is self-rewarded when it finds the targeted box. This is repeated several times, and then the cover is loosely closed. As the weeks progress, the loosely closed boxes are scattered, and the dog is allowed to work off leash in the enclosed area, with the other dogs safely crated away from the search area. This also gives the other handlers an opportunity to observe the other dogs as they conduct their searches. As the dogs become more proficient, the target box containing the food may be hidden behind an overturned table or boxes may be placed on chairs, both to encourage the dog to hunt or to encourage them to pick their noses up off the ground.

The next class level, Into to Odor, is when the food is paired with the first scent, sweet birch. Birch, for those

who have never smelled it, smells very much like winter-green – at least to humans! Again, the dog starts off with the box drill (a line of 6 boxes) and gets a good whiff of the scent as it self-rewards with the food. As the dog becomes more proficient at finding the scent, the food is weaned away from the odor. Now the dog is searching for scent alone, and when he finds it, is given a food reward at the odor source by the handler. This food reward reinforces the successful hunt! During this entire process, the handler is keenly watching the dog's body language to learn the cues given when the dog is “in odor.”

Now the real fun begins! The search area moves to interior rooms, vehicles and exterior areas! Again, a small amount of food may be paired initially, to help the dog understand that the game is continuing, that only the area has changed. As the dog becomes more experienced at finding the scent and the handler becomes better at being able to “read” the dog, they move into more advanced classes, even taking those classes “on the road” to other locations. Dogs are encouraged to be successful in their searches and corrections to the dog are never given.

At some point, the remaining two odors, aniseed and clove, are introduced, first by pairing with the birch, and then working them individually.

Costs for this sport are minimal. Dogs are encouraged to wear a harness, which will allow them to pull safely (they also learn that the harness means they are going to play the sniffing game) and a long line, which allows the dog freedom to safely move away from the handler, is also used. If you want to practice on your own, you can buy a small bottle of the essential oils: sweet birch, aniseed (not Star Anise) and clove bud; a few Q-tips which you have cut in half and stored in a small glass jar and scented with a few drops of the essential oil, and a metal tin with a few holes poked in it, and conduct your own searches. There are also complete kits available for purchase online.

Nose Work trials have been held on the West Coast since 2008, and the first New England trial was held in Massachusetts this past May, with another planned for the Fall 2010. The dog and handler must both be registered with the National Association of Canine Scent Work (www.nascw.net) to compete; it is a one-time registration for the dog, but the handler must renew his/her registration each year. In addition, prior to competing, the dog must have passed an Odor Recognition Test (ORT), which indicates proficiency for that odor. Titles can be achieved in this sport, with an NW1 title for the target odor, birch, an NW2 for the target odor, aniseed, and an NW 3 for the target odor, clove. As expected, each level of competition involves more complex searches.

An actual trial consists of the dog searching all 4 venues: a box drill, an interior search, a vehicle search and an exterior search – successfully complete all 4 and your dog will be awarded his title! In addition, special awards are given

to dogs and handlers indicating their proficiency and teamwork in a search venue, and there is also a special award given to a rescue dog, even if it didn't receive a title!

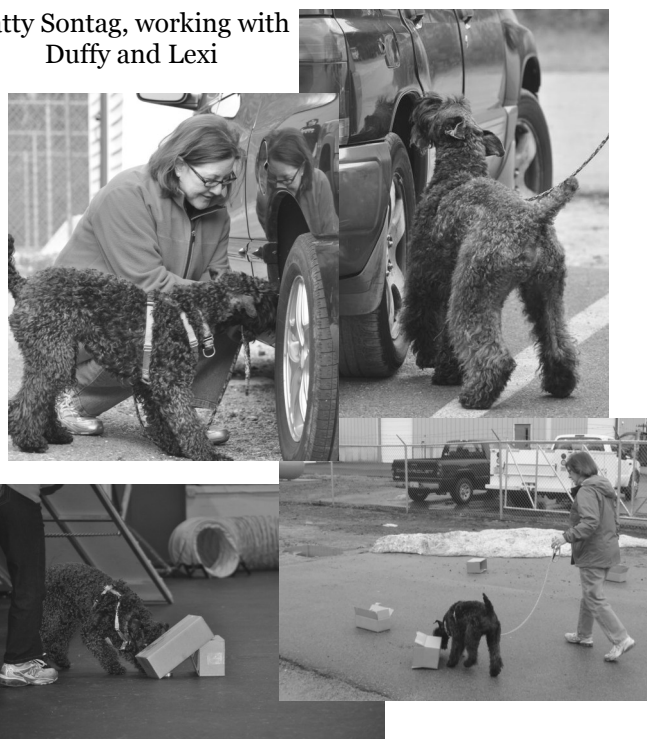
My late Kerry, Duffy (Wildside's Quiet Man UD RE) and I started training for this sport in January 2010. Sadly, I lost him 6 months before the first trial was scheduled in our area. The joy he exhibited when the harness came out clearly indicated his love for the sport. I started my young Kerry girl, Lexi (Calix Worth the Wait) in training late last year, and she passed her ORT for birch in January 2011. She exhibits the same enthusiasm and determination, and, as we travel the Nose Work road together, I have no doubt she will do well also. Other Kerries are training for Nose Work as well.

The first Kerry to be titled in Nose Work is Meggity Meggity Meg, a 12.5 year old Kerry who is also has agility titles in AKC (MX, MXJ, OF, OAP, NJP, NFP), NADAC (OAC, NJC, NGC) and USDAA (AD) and does therapy work in her 'spare' time with her owner, Carolyn Allen. This California Kerry was awarded her NW1 title in October 2010 and is currently working towards her NW2 title.

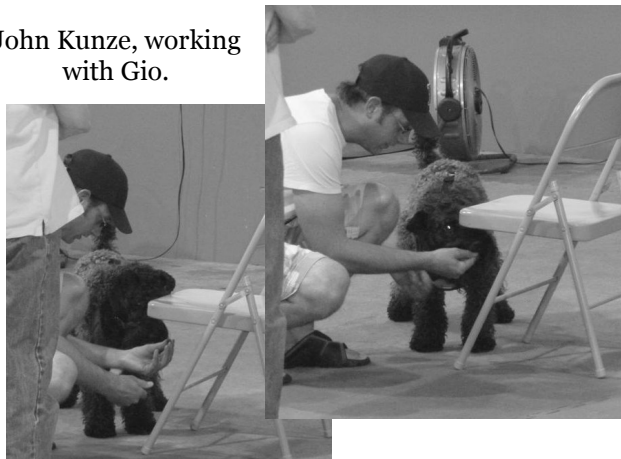
This sport allows us to have fun with our Kerries as they provide us a glimpse into the world of their superior sense of smell.

Bean and Dock Jumping

My wonderful journey of life with a Kerry Blue started on May 30, 2009, when I picked up my puppy from the breeder, Youlia Anderson (PennTerra's KBT). Since I am already



active in performance events with my Rottweiler, I knew this puppy would also be participating in activities when she got older. I love doing the sports with my dogs where their breed isn't the typical breed you

see participating. I do weightpulling with my Rottie boy and Bean is also a weightpull dog in training. I decided to look for another sport where Bean might also be the first in her breed to be titled and I looked into dock jumping. With the Kerry being the all around working and retrieving dog for the farmer, I thought this would be a good fit. I contacted the local club, Keystone DockDogs, because I wanted the proper introduction and foundation work since I knew I'd be competing with Bean. I was told there was a member who put some time in at a nearby dog pool to help with newbies in the sport and I was put in contact with him. He was excited to see a Kerry getting involved as he had never seen one competing.

If one does not have access to a pool, a lake or beach will work equally well since the first step is teaching them to swim. When I arrived for the first time at the pool, the Key-

stone member told me that the first visit was just for a positive experience with no pressure. I put a life vest on her and let her run around and play. Even just standing in the water was praised, and nothing was rushed. It must be FUN for the dog. In the beginning it's just play, play, play. Place the toy in front of them and LOTS of praise if they pick it up. As they get more comfortable in the water and with their toy, tossing it a little farther will eventually have them retrieving it. As the toy gets farther out, the dog tends to rush in the water with some splashing in the excitement to get the toy. This is the start of teaching them that a splash is fun and part of the play. Picking one particular toy for this game (and it is a game for the dog) and it being used for ONLY this game is important. By doing this, eventually the dog will get super excited just seeing the toy because he knows what is about to happen and then it only takes a little toy play to get them revved up while in line at competition.

Once Bean was swimming and retrieving, it was time to introduce her to the dock. It is very important not to rush them jumping off the dock, they have to *want* to jump. In competition, pushing, tugging, or yanking the dog is not allowed so it is important that it not be done in the beginning to potentially shut them down. When I first attempted to ask Bean to jump, I engaged her with some play



with her toy to rev her up. She chased it, jumped for it, and tugged on it, increasing

her desire for the toy. We walked up to the end of the dock and I dropped her toy right in front of the dock. You have to make the dog think that they can get it, and keeping it in

close in the beginning increases the chances of them thinking they can do it. After I dropped it, I praised her if she looked at it



with a “yes, good girl”. The more she acted interested in the toy, the more excited and encouraging I got. This

is where revving them up and, in the beginning, the encouragement of the splashing comes in VERY handy because Bean went off the dock quite readily. If she hadn't, I would have gone back to the other end of the pool (or shoreline at a lake) and done a few retrieving with some splashing repetitions. Once she jumped off the dock, I gradually threw the toy farther out. Bean was a VERY fast learner and in all, this took about a month. I went to the pool about once a week and stayed about two hours.

So now Bean was a dock jumper. Now what? Well, she was ready for a competition. It really is that simple. Dock jumping is a great sport in that there is very little training involved in order to compete. It's not about training the swimming and retrieving or the dog having an abundance of energy, it's about their DESIRE for their toy and tapping into that desire (often called a “toy drive”). It's not like agility, rally, or formal obedience; once they are jumping, you enter! Bean LOVES to play and LOVES her toys, so for me, it was easy from day one. She FLIES off the dock. However, no two dogs are alike and what is “easy” for one owner may not be “easy” for the next. This does NOT mean one is a better candidate than the other and it is important to not get discouraged. It just means you have to take the steps a little slower. My Rottweiler, for example, thinks this jumping off the dock stuff is in no way fun, so I need to

work with him more on the shoreline and his desire for his toy (which he has, just not in the water). If you have a dog that is needing more steps in the beginning, just take it slow. Train for the race, not the sprint.

There are three sanctioning organizations in dock jumping: DockDogs (dockdogs.com), Ultimate Air Dogs (ultimateairdogs.net), and Splash Dogs (splashdogs.com). I chose to compete in DockDogs because they have regional events as well as traveling nationally, and I can join a local club (Keystone DockDogs). However, UAD (and now SplashDogs) is partnered with UKC and one can earn UKC jumping titles so I will compete in UAD in the near future. For DockDogs, a membership with DockDogs Worldwide is required to have the titles recorded and the title goes with the team (handler and dog), not just the dog. For

UAD, if you want it to earn UKC titles you must submit your registration number when entering, but UAD does have their own titles.



A title is awarded after the team earns 5 legs in one division:

Novice 1'-9'11”
Junior 10'-14'11”
Senior 15'-19'11”
Master 20'-22'11”
Elite 23'-24'11”
Super Elite 25' and up

The dock is 40 feet long, 8 feet wide, and 2 feet above the water surface (this may vary slightly with each organization). In DockDogs, the body of water can be either a pool or

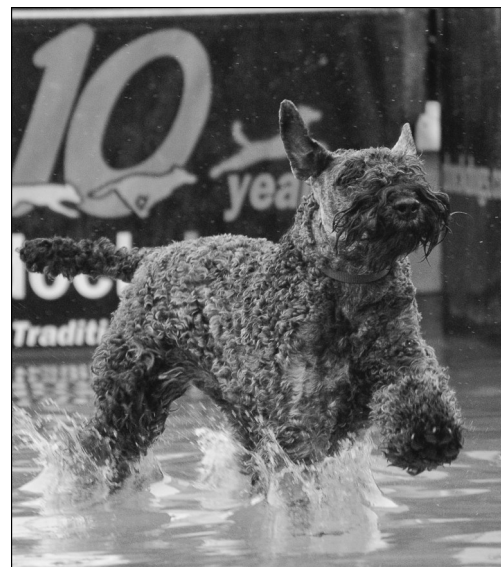

a lake at least 4 feet deep. The dock is covered in a turf type carpet for traction and safety. The team can use any amount of the dock they choose and can start from any point on the dock. For instance, with Bean's first event I chose to keep her up close to the edge of the dock and I only went back about 10 feet so she kept her confidence. In her second event, I went back 20 feet. I knew she was a little more solid with her jumping and a little more used to the environment. The bigger, more experienced dogs use the entire 40 feet. The competition is called a wave, with 2-3 waves per day and practice time in between. In each wave you have two jumps with the longer of the two jumps being your official score. The jump is measured from the end of the dock to where the tail set enters the water. This way, all the dogs are judged fairly against each other. The handler has 90 seconds on the dock to work with the dog, which some people use to play with the dog and build up his energy. Green dogs sometimes need the time for extra encouragement, while others hardly need any time and just blast out a great jump. The top six dogs of each division move on to the finals, so a jump of 8 or 9 feet could easily be in the Novice Finals. There is then an award ceremony with the winners of each of the divisions.

There are two techniques used in preparing the dog to jump. One is called The Chase and the other is called the Place and Send. The Chase method is where the dog is placed at one end of the dock and the handler stands at the other end of the dock with the pool. The dog is released and the toy is thrown as the dog is about to jump, creating a jump with nice height and (hopefully) distance because the dog follows the toy, trying to catch it. This method takes some mastering because timing is critical and an "off" toss can affect the performance of the dog. The Place and Send method is where the dog and handler go up to the edge of the dock and the toy is thrown into the water. The dog is encouraged

to see the toy in preparation to jump. The handler then takes the dog back to the desired point on the dock and releases him. Sometimes you will see the handler run with the dog for extra encouragement and excitement for the dog. I currently use the Place and Send with Bean because she is still young, still learning, and not solid on her sit/stay yet. I will be transitioning to The Chase as we mature as a team.

Dock jumping is a lot of fun for both you and the dog, and jumping with the first titled Kerry Blue (confirmed by Dock-Dogs) makes my experience even more special. I knew I wanted a Kerry



"someday", but it came a reality so much earlier than planned. My female Rottie had recently been diagnosed with cancer and while Youlia had a litter on the ground, I really wasn't calling her to say "I want a puppy". All the girls were spoken for, but Youlia asked if I wanted to be notified if one of the homes fell through. I told her if that happened, it would be my sign that it was meant to be. A week later she emailed saying a female puppy was mine if I wanted it. It's truly a magical connection when your dog picks you to be their owner. I still remember my heart melting seeing all those adorable puppies running around Youlia's yard when I went to pick up Bean. At 17 months old, she's still melting my heart.

1. Category 1 Service Dog:

2. Category 2 Therapy Dog:

Therapy dogs are trained to provide care and comfort to patients and residents in medical care facilities, retirement communities and shelters; Examples include retirement communities; senior centers; veterans homes, military hospitals; healthcare facilities, hospitals, hospice and medical care facilities; children's hospitals, rehabilitation centers such as shelters for homeless, battered women and children; military and veterans hospitals and recovery centers for wounded soldiers.

3. Category 3 Educational Service/Therapy Dog :

Educational Service Dogs or therapy dogs work with children in public and private schools in academic and special needs areas; Programs can include but are not limited to the Bite Avoidance programs in schools and organizations such as The Boys and Girls Clubs; Canine-Assisted Reading Programs in Schools and Libraries; Safety School Crossing Program; Programs include Kerries teaching children how to interact with dogs and build a positive relationship with dogs;

4. Category 4 Exemplary Companion Dog /Act of Exemplary Performance:

The Exemplary Companion Dog is the Kerry who has performed a one time event of an exemplary act, contributed to others or a Kerry who has exhibited companionship to an individual under exemplary circumstances (Example: saving family members from a fire in the home or acted as a companion to a person who is terminally ill;) Other examples of exemplary performance include Kerries who serve in search and rescue, or work with military, firefighters and police in security and rescue.

5. Category 5 KIF In Memoriam:

This is a special category for those Kerries who would have qualified in one of the categories above, but have passed away, even if it was years ago; 2011 is the last year we will be honoring those special Kerry Blue Terriers who are no longer with us, but contributed to Society or to the Individual in the past, in special ways. If your Kerry meets any of the categories 1 through 4 listed above, but has passed away, regardless of the number of years ago, you and your Kerry's contributions will not be forgotten.

Award Criteria:

1. The dog must be a purebred Kerry Blue Terrier;
2. The dog must be nominated by a member of the USKBTC to receive the award/recognition; the owner(s) of the dog does not need to be a member of the USKBTC to receive the award/recognition;
3. For the first two years of the award, (2010-2012) AKC and other certification registry requirements for the applicant are waived and will not be required; after which a minimum of AKC-PAL registration will be required; additional requirements for certification may be added per award category, as necessary.

Award:

- Each qualified recipient who contributes in one area receives a Certificate and Kerry It Forward Medallion with a white star;
- Each qualified recipient who contributes in two areas receives a Certificate and Kerry It Forward Medallion with a red star;
- Each qualified recipient who contributes in three areas or more receives a Certificate and Kerry It Forward Medallion with a Blue star;

Recognition: Each recipient will be recognized in Blueprints; on the USKBTC website, at Montgomery and his or her local specialty, if desired.

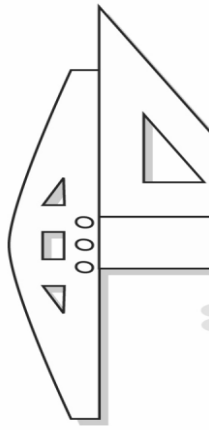

A Word from Charitable Funds...

As many of you know the US Kerry Blue Charitable Fund was established in 2002. Its purpose was to serve the Kerry Blue Terrier in four important areas:

- 1) Rescue Fund** – this fund supports grants used to provide Kerry Blue Terrier rescue services.
- 2) Health and Genetics Fund** - this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier.

AN OLD DEBATE

As you already know, Charitable Funds has four funds: a general fund; a rescue fund; an education fund; and a health and genetics fund. I'd like to raise an old issue that touches on three of those four funds.

By the way, before I begin my short epistle I'd like to thank each of you who supports Charitable Funds. Remember, your donations are tax deductible.

As the title suggests, this is an old debate but maybe it would be good for the breed for us to revisit it once again. The question is this: should or should not older breeders continue to breed? And, if you believe a breeder can get too old to breed, at what age should he or she quit? Yep, this is opening quite the bag of kibble.

You have heard that the total number of AKC Kerry registrations per year is dropping, some would say to dangerously low levels. Given that fact, should we encourage more breeding, including breeding by long-time fanciers who are, um, getting up there in age? Or, should we discourage our senior-golden-mature, and often leading breeders from producing more litters?

In light of our shrinking numbers here in the States, why would we ever want to discourage older breeders from continuing to breed? Some will say that breeders have an obligation to watch over the puppies they produce for the life of those puppies. Some say the breeder is the one responsible for retrieving, re-homing, or rescuing each puppy they produce should that puppy ever need assistance, ever. If you are of that camp in this debate, then at what age would you suggest a breeder is too old to continue breeding?

Let's say a Kerry lives for 14 years and that a breeder is healthy of body and mind until, um again, 78 years old, does that mean that breeders should quit breeding at age 64? I can hear a few of you barking and yapping already. You can fiddle with the numbers and argue until you are Kerry blue in the face, but you'll find an easy answer.

Is this any of Charitable Funds' business? I don't know, but it does seem to me that this question touches on education issues, rescue issues, and health and genetics issues--maybe H&G issues of the breeders as much as of their Kerries. So, let's think about all of this, and talk about, and see what we come up with.

Meanwhile, I'll encourage long-time breeders to consider having another litter to help us keep our numbers up. And, then when we oldsters get too old to breed again, maybe we should consider making our good breeding stock available to young fanciers so that our breeding program doesn't get lost to the breed when we ourselves cross the rainbow bridge.

The mission of this awards program is to recognize the versatility of the Kerry Blue Terrier and recognize United States Kerry Blue Terrier members and their dogs upon achieving titles in more than one discipline of competition. Current USKBTC membership is necessary to be eligible for this awards program.

List of Disciplines eligible for awards:

AKC Agility Title

AKC Conformation Title

Earth Dog/Hunting Title: Hunting Certificate (HC) awarded by American Working Terrier Association

Herding Trial Dog Title: AKC Herding Tested (HT) or Pre-Trial Tested (PT), or Herding Capability Title (HCT) awarded by American Herding Breeds Association

AKC Obedience Title (CD or higher)

AKC Tracking Title

AKC Rally Title

Wild Card: A performance title from a discipline not otherwise listed may be used for one of the seven award levels, subject to approval. Examples include Flyball, Canine Nosework, AKC Coursing Ability, or Dock Dog.

Eligible dogs will be submitted for award(s) by owner(s) in the following manner: Properly filled in application including:

Enclosure of photocopies of title certificates (normally non-AKC) if needed for verification.

Enclosure of comments or brief biography of dog's accomplishments which will be published in the Blueprints (subject to editing) along with award presented, including name of owner(s) and breeder(s). Photos sent by owner for inclusion in *Blueprints* will be printed subject to room available.

Award applications will be accepted within the following fiscal year time period: August 1 to July 31. Members will submit applications during this time period. Those applications received after July 31st will normally be held over for the next year for qualification and presentation. Award presentation will be made at the Annual General Meeting in October (Montgomery County). Awards not presented at the AGM will be mailed to recipients.

ACTUAL AWARD: The award will be a certificate suitable for framing signed by the president of the club and Versatility committee representative to include the following information:

The name: **United States Kerry Blue Terrier Club Versatility Award**

The name of the Award tier (see below)

The registered name of the dog (with all titles, as the owner wishes it to appear on award)

The name of the owner(s) of record (at least ONE owner must be a current USKBTC member)

The date the Award is presented

ONE certificate will be presented per dog for each award tier.

A keepsake memento commemorating the award will be awarded at the club's discretion.

Award tier structure is as follows:

The **Bronze Award** is presented to the Kerry Blue Terrier earning titles in two different disciplines.

The **Silver Award** is presented to the Kerry Blue Terrier earning titles in three different disciplines.

The **Gold Award** is presented to the Kerry Blue Terrier earning titles in four different disciplines.

The **Platinum Award** is presented to the Kerry Blue Terrier earning titles in five different disciplines.

The **Emerald Award** is presented to the Kerry Blue Terrier earning titles in six different disciplines.

The **Diamond Award** is presented to the Kerry Blue Terrier earning titles in seven different disciplines.

*** Please Note:** Canine Good Citizen (CGC), Temperament Testing (TT), and Therapy Dog International (TDI) along with other therapy or service dog certifications are not considered competitive titles. Therefore they do not qualify as eligible disciplines for these awards. These certifications may however be included in the dog's name as stated on a Versatility Award should the owner wish them. The owner is responsible for submitting the dog's name as it should appear on the award. Members wanting their Kerries' therapy or service dog accomplishments recognized are encouraged to apply for the USKBTC's "Kerry It Forward" awards.

Additional Notes: The accomplishment of any of these disciplines may take more than one fiscal year to achieve. Therefore the applicant may submit an application along with proof of awards at any time provided that the owner submits the application by the stated deadline to qualify for that year's award presentations. A separate award and certificate will be awarded for each additional discipline tier achieved no matter what time frame is required to achieve that award. Example: Dog A is already a Ch., CDX, TD. Therefore he will immediately qualify under (3) disciplines (conformation, obedience, tracking) making the dog eligible to receive (2) awards (Bronze and Silver) from the club. To recognize those members who have achieved multiple disciplines in the past with their dogs, awards will be offered to eligible title holders (with proper application and proof of title) retroactive back to and including the year 1995. All titles (as listed above) earned are eligible for tier qualification provided that dog earned at least ONE discipline title after 1995.

 3. You will be promptly notified, in writing, of the Board's action.
 4. You will be provided with a copy of the approved Constitution and Bylaws.
- This Membership process can take up to six (6) months or more, due to the Quarterly publication of BLUEPRINTS, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership; your application fee will be refunded.

**THE UNITED STATES KERRY BLUE TERRIER CLUB
CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

I. RESPONSIBILITIES AS A MEMBER

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
