

Breeder Spotlight Marie Sostmann ~ Pot 'O' Gold Kerries

In this article, I would like to 'Spotlight' breeder Marie Sostmann of Pot O' Gold Kerry Blue Terriers. Newly elected, Lifetime Achievement Award recipient, Marie opened up her home to me on May 8, 2017 sharing stories of her journey down the road with the Kerry Blue Terrier over the past 35 years.

Before arriving at Marie's house, traveling from the East Coast for KerryFest at Purina Farms, the first week of May was filled with many highlights. To mention a few, one included listening to a man at ringside share his love of the breed by mentoring a group of people that kept getting larger, critiquing all going by in the ring and answering questions defining his opinions with knowledge gained by sharing many years of his life surrounded by the Kerry Blue Terrier. Technically, I was not part of the group, but was doing my best 'Irish Eavesdropping.' Another highlight was having dinner with a group of fanciers, celebrating one of their birthdays and finding out that, with one couple at the table, I shared the same town growing up on Long Island NY and they knew my father from many days gone by.

At the conclusion of KerryFest, as the trip started to Marie's house, driving due west on I-70 towards Kansas City in the warm sunny weather, numerous signs for 'Wine Tastings' at the local vineyards off the road were very inviting but I held my ground and found a Dunkin Donuts instead. However, I did think to myself 'Wine tastings and Kerry Blue Terriers.' Let's have a toast!

Finally arriving at Marie's beautiful home and being graciously welcomed by herself and her Kerry Daisy was such a privilege. A few hours were not enough to share the many memories and experiences encompassing over 35 years and 13 litters of Pot 'O' Gold Kerry Blue Terriers. But it only took a few minutes to know that she is a great ambassador for the breed. Listed below are just a few contributions Marie Sostmann has made to the Kerry Blue Terrier and the USKBTC:

- -USKBTC Member for over 25 years
- -Served on the USKBTC Board of Directors for two terms from 1994-2000
- -Vice President of the USKBTC for four years from 1996-2000
- -Served on Rescue Committee
- -Served on the Life Membership Committee.
- -Served as Nominating Chairman
- -Maintained a library from which USKBTC members could request copies sharing knowledge.
- -Helped in updating of Bylaws
- -Co-Chaired the USKBTC Futurity in 1996 and 1997 with entries in those two years of 65 and 67.
- -Bred over 20 AKC Champions
- -BOS Winner at USKBTC Traveling Specialties in 1994 and 1995 with Pot O Gold's 'Luck O The Irish'. He sired over 20 AKC Champions!
- -Contributed to the rescue of numerous Kerry Blue Terriers after the owner breeder died and worked behind the scenes on many occasions, with the help of others, to get Kerries out of bad situations into USKBTC Rescue.

All of these contributions listed above were not given to me by Marie, but found in old *Kerry Blueprints* articles giving her the title of 'Modest Marie.'

Born in Rockford Illinois, Marie met her husband as a patient in a hospital where he was an intern. After getting married, they moved from Detroit to San Antonio where he did his fellowship

becoming a Radiologist. This led them to the Kansas City area where they rented a home on a busy street. As they started to look for a house to call their own, they almost did not take a look at one a realtor recommended because it was on the same busy street. After finally agreeing, when Marie opened the door and looked out the bay window into the big tree lined back yard she said 'I want it!' knowing it was perfect for the 2 schnauzers, cockapoo, poodle and yorkie that were also part of the family! In addition, they would also be raising two sons, Scott and Greg, in the house built in 1950. This day, both sons live in the surrounding area working in the computer and accounting fields. Now that she was settled, her life would change just by taking a glance.

Almost 30 years ago, in January 1987 Marie had her first litter of Kerry Blue Terriers, but her first look at a Kerry was at a local benched show in the Kansas City area. From a distance, she could see this curly brownish coated puppy in the sun with its arms around the neck of its owner as it camped in his lap. Immediately, she said to herself "I have to get one of those." Walking over, she watched as Camshron's 'Flash' won the group. After much searching, this led her to finding a newspaper advertisement for Kerry Blue Terrier puppies available from breeders Marion Gough and Ellen Wexler. Only having two left, Marie took the Kerry available as a pet 'Gaymar's Pot of Gold Heidi'. Of course, in a very short period of time, she was looking for another Kerry to keep Heidi company and Susan Godby had one available that needed to be shown. So she acquired 'Gaymar's Misty Blue Diamond' quickly finishing both and falling in love with the Kerry Blue Terrier

Marie earned a Bachelor's of Science degree with credits towards a Master's and became a registered medical technologist. With this background, she became hooked on studying pedigrees and read as much as possible to try and create the best Kerry Blue Terrier without ever knowingly accepting a flaw in bloodlines that she thought would not create the best outcome. Correct movement and temperament are attributes she regards highly. Marie states "Any breeding that I did, my first priority, other than health, was temperament. Number two is movement. If you see a Kerry with spectacular movement, you know it instantly. It is like they are floating in the air." Also being a researcher at heart Marie states "I Encourage people to read! Learn the science and genetics of it. It is so important to be knowledgeable." Some favorite books mentioned included: Genetics of the Dog-Malcolm B Willis, Canine Hip Dysplasia-Fred L. Lanting, The Dog in Action-McDowell Lynn's, Canine's Reproduction-A Breeder's Guide-Phyllis A. Holst, MS, DVM and The Kerry Blue Terrier, Edith Izant.

Acclaimed breeders of their time, Bee Schlesinger and Fern Rogers, were both mentors to Marie giving advice and later breeding to her line on Pot 'O' Gold Kerries. Living relatively close to each other, they strived to enhance the Kerry Blue Terrier when their paths crossed. Marie has produced and had approximately 25 Kerry Blue Terriers Champions of her own only breeding once every year or two having her main goal to make the next generation better than the last. One in particular, 'Luck of the Irish' sired 23 champions himself! Some words of advice from Marie on successful breeding is "Learn what you're doing. See what's behind the pedigrees. See what the dog has produced. That is really important. Research lineage." Always being with puppies 24/7, there was no need for temperament testing. Placing dogs at 4 months, she knew all traits of all puppies and shared them with future owners for many successful transitions to lifetime homes. "Breeding never felt like I was competing against another top dog or kennel. I was always competing against myself. I loved the genetics of breeding more than anything, including studying how to develop all traits - even though color is the one that I've found most challenging to figure out.


Just by her willingness to share her knowledge of the Kerry Blue Terrier, she has made many friends that hold her in high regard, but more importantly hold dearly the sincere advice and comradery always available with her friendship close to their heart. A few examples are expressed below:

Gary Alu shared "Marie instilled in me how important well colored and correct coated Kerries are. She has always been there for me during my litters, offering great insight and wisdom into all issues pertaining to breeding and life! Just a phone call away at any time of the day or night! Always supportive, Marie inspires with a humbleness that all should admire! I am truly blessed to be able to call Marie Sostmann a mentor and more importantly a dear friend I can always count on."

Gene Possidento comments that "I'm thinking Marie is the hub of a wheel with a lot of spokes. A great many Kerry breeders connect up with Marie. A lot of us got to know her when she was the USKBTC club librarian. She was always helpful, gave good common sense advice and could be a great person to tell your troubles to. Her usual comeback would be, "Well, when that happened to me...". When you as a breeder have troubles, it is always wonderful to have a friend who has been there, done that and can tell you how to get through it. For me, that person is Marie."

So let's have a toast to 'Modest' Marie Sostmann of Pot 'O' Gold Kerry Blue Terriers for her success in making the next generation of Kerries 'better than the last' and sharing her knowledge and true love of this great breed to anyone interested making such a difference!
















I'd Like You to Meet Parker! 2016 USKBTC Charitable Funds *Kerry It Forward* Award Recipient



AKC CH/RBIS UKC CH Symphonie's If I Had You, CGC "Parker"

Although Parker has a well-known pedigree, he would rather be known for his work with children, seniors, anyone who is struggling with challenges of life and for being there as an assistance dog for his owner, Stephanie Clark.

Parker is the 2016 recipient of our Kerry It Forward Award, Blue Star Medallion, awarded for three or more areas of contribution to the Kerry blue terrier, Canine-Humanitarian Bond. His areas of recognition include serving as a Service Assistance dog to his owner Stephanie Clark; serving as a Therapy Dog in healthcare facilities; and as a Therapy Dog to seniors in retirement facilities. Recently, Parker has added a fourth service. Parker visits school children K-8 experiencing emotional development delays, offering his encouragement and support. Parker is also receiving his AKC THDN title soon and is well on his way to his THD title, working as a Therapy Dog through Gabriel's Angels. In his free time, during the holidays, Parker also dons a costume and serves as "Santa Dawg" at the Teen Outreach Pregnancy Services' annual Christmas Party.

Parker's journey these past seven years was not an easy one. Probably, in some very special 'Kerry way,' Parker conveys his strength and courage to overcome his own health challenges, to those he helps today.

His story is best told in his owner's own words.

Parker's owner: Stephanie Clark:

"When I first brought Parker home, he had some rather large expectations to fill! His dad, Cruiser, had done some pretty big winning in his time, and it was anticipated that Parker would do the same. Between 9-11 months of age (2011) Parker contracted Valley Fever. We put him on the anti-fungal medicine, Fluconazole, for 60 days. At that point, his titer was reevaluated and it came back negative. He was taken off the medicine. Worrying over, right? One would think! There is the possibility that valley fever will reoccur in dogs that have previously been affected by it. Yet again I believed that would never happen to my special boy!

Fast forward to the year 2016 and after being completely medicine-free for 2 years, Parker's Valley Fever came back with a venge-ance! Back on the medicine he went! While Parker currently shows no clinical signs of valley fever, except for an elevated titer, I always remain hopeful that his titer will come back negative. There is no way to know, exactly, where the valley fever is in his body, we just know it's still there! Parker has done his due diligence and donated blood at the Valley Fever Center for Excellence. Hopefully his blood can help the researchers find a vaccination and other dogs won't have to go through what Parker has!

Parker did obtain his CH title before having to be neutered, due to the Valley Fever. Since his specials career was over before it really started, I looked into other options. Who knows where else this will take Parker (and me)!! His sweet, stable temperament brings a smile to everyone that he meets and an extra bonus; he is an incredible ambassador for our breed."

A Word from Charitable Funds...

The USKBTC Board of Governors established the US Kerry Blue Charitable Funds, Inc. in 2002, a 501(c)(3) non-profit under the U.S. Internal Revenue Code. The USKBTC is the official organization recognized by the AKC with responsibility for protecting and promoting the Kerry Blue terrier in the United States. Establishment of the Fund occurred after a lengthy and thorough evaluation of the status of the breed in the U.S. and the recognition that strategies were needed to ensure the long-term well-being of the Kerry Blue terrier.

The goal of the Fund is to provide, in perpetuity, a safe, secure means for breeders, exhibitors, owners and friends to contribute financial support for Kerry Blue Terriers. The Fund is independent of the USKBTC Board of Governors, but linked to our governing board through interlocking directorates. This arrangement assures that Charitable Funds will be a permanent giving option to the Kerry fancy, but will be buffered from the ebb and flow of fancier personalities and politics.

There are four active funds to serve the Kerry Blue Terrier in the Charitable Funds portfolio:

- 1) Rescue Fund this fund supports grants used to provide Kerry Blue Terrier rescue services.
- 2) Health and Genetics Fund this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier.
- 3) Education Fund the education fund supports education of all those interested in the Kerry Blue Terrier including publications, websites, and seminars.
- 4) General Fund donations to this fund are used to support the work of the other funds through internal grants to those funds. Undesignated gifts will initially be held in this fund.

Since Charitable Funds was established, those who love this breed have worked diligently to build its assets. The USKBTC undertook major support of the PNA Research being done at the University of Missouri, and contributors finally received welcome news of a test for this dreaded disease. To date we have awarded over \$20,000 in grants to support Health and Genetics, Education, and Rescue ~ all thanks to your donations.

We believe there is much still to be done. While we know the Kerry as a healthy breed, we also know those who have lost a Kerry to cancer. We hope to make a difference going forward through joint efforts with genetics laboratories and research facilities. Helping the Kerry Blue flourish is still the #1 goal of Charitable Funds.

Our committee has many goals. The first is to communicate more efficiently through a newsletter posted to the USKBTC website on a monthly basis and emailed to those wishing to receive it, informing all about where donations are being utilized. We must also grow our financial resources substantially in order to have meaningful impact. LEPTOSPIROSIS

Leptospirosis is a disease process affecting all mammalian species and found on all continents of the world. It is important to have awareness of this illness as it not only causes life threatening disease in dogs, but it can also be transmitted to humans which poses a public health concern.

In this article I will touch upon the clinical signs, treatment options and preventative measures that can be taken concerning this disease.

Leptospirosis is caused by the bacteria lepstospira, of which hundreds of different strains exist.

In the U.S. there are four that have been identified as being the main cause of disease. The bacteria is most present in water and soil, with a higher incidence in areas that are warmer and that have a higher annual rainfall.

The disease affects all breeds and all ages of dogs. Initially it was reported to affect mostly sporting, herding and working dogs, but now it is seen in higher numbers in smaller breeds including the toy breeds. Urban areas seem to have a higher risk of disease than rural ones. Raccoon, rats and bats seem to be the primary hosts, bringing the bacteria to the more developed areas.

The bacteria is passed through the urine of hosts, and the dogs become infected when the organism enters the body through broken skin or mucosa. Coming into contact with infected urine, urine contaminated soil, water, bedding or food can cause a dog to contract the disease. In addition, eating a contaminated carcass or less commonly, through breeding, transmission can occur. An infected bitch can also transmit the bacteria to its fetus. Other risk factors include drinking from rivers, lakes and ponds, and contact with rodents and other wild animals.

The leptospira organism has an affinity for the kidneys, but can also affect the liver, eyes, intestines, nervous system, vascular system, spleen, lungs and genital tract. Consequently the clinical signs displayed by an infected dog pertain to injury to one or any of these organ systems. The degree and severity of signs varies anywhere from none to death. Some dogs will show no signs, overcoming the infection through their own immune system with no treatment necessary. Others will have mild disease with non-specific signs, such as a transient lack of appetite and lethargy. There will be others, however, that will get a more severe illness and will show the following signs: vomiting, diarrhea, lack of appetite, dehydration, lethargy, fever, shivering, muscle tenderness, painful swelling of the eyes, increased drinking, increased urination, trouble breathing, pale and yellow mucous membranes. Bleeding disorders can also occur and will result in blood tinged urine, saliva and stool, nosebleeds and tiny pinpoint red dots on the gums.

Progression of the disease can lead to kidney failure with or without liver failure and death.

Diagnosis of the disease requires a visit to the veterinarian and the performance of multiple tests. These may include blood and urine tests, radiographs and possibly ultrasounds of the chest and abdomen. Testing may be extensive and costly, but necessary for the well-being of the dog.

Once a diagnosis has been made, aggressive therapy needs to be instituted. The earlier the initiation of treatment, the better chance of a full recovery. Mortality rates are in the range of 10-30% with moderate to severe disease, so early and aggressive treatment is important. In most cases treatment will involve hospitalization with fluid therapy, antibiotics and other forms of supportive care. It must be noted, that even with successful treatment, residual kidney and/or liver damage can remain with the dog for life.

Prevention of the disease can be achieved through vaccinations. Inoculating the dog with all four strains of the bacteria is recommended on a yearly basis. Many anecdotal cases of vaccine reactions have been reported causing concern among dog owners. Some of these observed reactions have involved intense itching and swelling of the face, weakness, depression, vomiting, diarrhea, difficulty breathing and, if unattended, can lead to death. It appears that smaller dogs, less than 10 kg in weight, tend to be more prone to reactions. It is still recommended for dogs to get the vaccines in areas where there is incidence of the disease. Treatment can be given to the dogs prior to administration of the vaccine in those dogs that are prone to reacting. Many recommend giving the vaccine apart from other vaccines, especially in the smaller dogs

Even though transmission to humans is low, if your dog has been diagnosed with leptospirosis, it is recommended that certain cautionary steps be taken.

- 1. Administer the antibiotics and medicines as directed and until fully completed..
- 2. Avoid contact with the dog's urine, feces and saliva.
- 3. If the dog urinates inside the house, clean immediately with a household disinfectant using gloves.
- 4. Wash hands after handling the dog.
- 5. Prevent the dog from urinating near water sources where other dogs may swim or drink from.
- 6. If you are pregnant or immunosuppressed, talk to your doctor.

Leptospirosis is a bacterium that can cause severe illness in dogs and that may be more pervasive and present in your area than we might think of. Please consult with your veterinarian about the options and preventive measures that are available to you and your dog.

Summer Water Dangers for Dogs

Summer season is upon us and with it comes swimming time! Swimming is not only a fun activity but it also provides an excellent way for your dog to exercise without placing much stress on his muscles and joints. Swimming, however, does not come without risks. In this article I will highlight some important risk factors associated with swimming and the measures you can take to avoid them.

One of the greatest dangers to swimming in ponds and lakes is an organism called cyanobacteria, also known as blue green algae.

This algae grows in ponds, lakes and anywhere stagnant water is found. Areas of water that receive run off from fertilized fields seem to have the greatest concentration. It is found

throughout the U.S. and also has worldwide distribution. This organism grows best in warmer climates so concentrations increase in the summer and early fall seasons. The algae can look like spilled green blue paint or green pea soup. The color can at times look red or brown and have the appearance of mats floating in the water. These mats can wash up on shorelines and look foamy.

At greatest risk for toxicity are dogs that enjoy swimming, and hunting dogs. Exposure occurs when dogs drink the water, eat washed up mats or groom their furs and paws after swimming. The degree of toxicity depends on the level of toxins in the algae, the amount ingested, and the size of the dog.

There are two types of toxins these organisms produce. One affects the liver and the other affects the nervous system. The onset of signs with the liver toxins can occur within the first few hours after ingestion. These signs include vomiting, diarrhea, lack of appetite, distended and painful abdomen, lethargy, weakness and yellow or bluish discoloration of gums. Death can occur 12-24 hours after exposure. Only a few mouthfuls need to be ingested to produce the above clinical signs.

The onset of signs for the nervous system toxins occur within 30-60 minutes after ingestion. These signs include weakness, lethargy, stumbling, muscle rigidity and trembling, depression, disorientation, paralysis, excessive salivation, seizures and difficulty breathing. Death can occur within minutes to hours after ingestion and will result from paralysis of the muscles that assist breathing.

Treatment for toxicity is not very successful, as the onset and progression of clinical signs occurs very rapidly. Treatment is best if it is instituted before the onset of signs. There is no antidote and prognosis is very poor once the signs have begun. Consult your veterinarian immediately if you believe your dog has been exposed to the algae.

Prevention is key to keeping your dog safe. Keep your dog away from bodies of water that contain the algae. Keeping your dogs leashed while walking along shorelines will allow you to prevent them from drinking the contaminated water or eating the mats. If you think your dog has been exposed to contaminated water, prevent them from licking their paws or coat and immediately rinse them off with fresh water or rub them down with a towel. Since these algae is also toxic to people, make sure to rinse hands off immediately after handling your dog.

Blue green alga is not the only health risk associated with swimming. Drinking lake and pond water exposes your pet to organisms and bacteria that can be harmful.

Leptospirosis is one of those organisms found in marshy or muddy water. Ask your veterinarian about the vaccine that is available to prevent against this disease. Giardia is another organism found in bodies of fresh water. The main clinical sign of this bacterium is diarrhea with occasional vomiting. If you suspect your dog has contracted giardiasis, contact your vet who can run a fecal test to confirm infection.

Besides the organisms mentioned above, common sense has to be exercised when taking your dog for a swim. Not all dogs are natural swimmers and life vests have to be provided for the safety of those that do not swim. When swimming in oceans or large bodies of water, be aware that large waves and undercurrents can

pose a hazard to the safety of your dog. Here are some other safety tips for your dog on swim day:

- 1. Apply sunscreen: dogs with light colored skin and thin coats can get sunburned.
- 2. Always rinse your dog thoroughly with clean water after every swim.
- 3. Bring fresh water to drink to decrease the amount he or she will consume from the lake or pond.
- 4. Clean and dry the ears thoroughly after every swim to prevent ear infections.
- 5. Dogs get tired from swimming but will not tire of going after the ball or frisbee being thrown into the water. Make sure to stop when you see

your dog getting tired. You want to make sure that your dog will be able to make it back to the shore or boat.

Many dogs love to swim and it is an activity to be encouraged as it provides great form of exercise and just plain fun. Just make sure to exercise safety measures and to be cognizant of some the risks above mentioned. Have a great summer!

Categories of Awards:

1. Category 1 -Service Dog:

Service or assistance dogs are trained to assist individuals with meeting special needs on a daily basis; these needs can be physical, psychological and/or emotional; examples include hearing, sight service dogs and alert response dogs who alert their human companions to seizures and other medical emergencies;

2. Category 2 -Therapy Dog:

Therapy dogs are trained to provide care and comfort to patients and residents in medical care facilities, retirement communities and shelters; Examples include retirement communities; senior centers; veterans homes, military hospitals; healthcare facilities, hospitals, hospice and medical care facilities; children's hospitals, rehabilitation centers such as shelters for homeless, battered women and children; military and veterans hospitals and recovery centers for wounded soldiers.

3. Category 3 -Educational Service/Therapy Dog:

Educational Service Dogs or therapy dogs work with children in public and private schools in academic and special needs areas; Programs can include but are not limited to the Bite Avoidance programs in schools and organizations such as The Boys and Girls Clubs; Canine-Assisted Reading Programs in Schools and Libraries; Safety School Crossing Program; Programs include Kerries teaching children how to interact with dogs and build a positive relationship with dogs;

4. Category 4 - Exemplary Companion Dog / Act of Exemplary Performance:

The Exemplary Companion Dog is the Kerry who has performed a one time event of an exemplary act, contributed to others or a Kerry who has exhibited companionship to an individual under exemplary circumstances (Example: saving family members from a fire in the home or acted as a companion to a person who is terminally ill;) Other examples of exemplary performance include Kerries who serve in search and rescue, or work with military, firefighters and police in security and rescue.

Award Criteria:

- The dog must be a purebred Kerry Blue Terrier;
- The dog must be nominated by a member of the USKBTC to receive the award/recognition; the owner(s) of the dog does not need to be a member of the USKBTC to receive the award/recognition;

Award:

Each qualified recipient who contributes in one area receives a Level I Certificate and Medallion;
 Contributions in two areas received a Level II Certificate and Medallion and those who contribute in three areas receive a Level III Certificate and Medallion.

Recognition:

 Each recipient will be recognized in Blueprints; on the USKBTC website, and at their local specialty of choice, if desired and requested.


