Catch 22

"It is a fact of dog show life, that after you have been involved with a breed for some 10 to 15 years or more, observing, studying, breeding and exhibiting, no judge (with the exception of the breeder judge) can possibly know as much about the breed as you do. They know more about all breeds in general but it is humanly impossible for any one person to be an "expert" on the fine points of every breed registered with the AKC. So a majority of the time you are paying for the opinion of someone who knows less on the subject than you do. Dumb? Of course. But for us it is still the only game in town.

Before I go on, I would like to point out that there is a place for both breeder judges and all rounders. The breeder judge while most knowledgeable about the breed sometimes will soul search and zero in on one aspect (forest for the trees syndrome). The all rounder unencumbered with knowledge of the fine points but still with a good eye for a dog, is the counterbalance to keep a breed on the road to constant improvement.

GRASSROOTS

I disagree that the AKC has the primary responsibility for the expertise of a judge. The AKC is the governing body, the keeper of records, the maker and enforcer of the rules. The Breed Clubs are the authors and guardians of the standards and they should be the educators. Symposiums held by All-Breed clubs or Associations of Specialty Clubs, taking one group or a part of a group at a time, are excellent places for judges and everyone else to increase and refresh their knowledge. Also, they're a boon to the program chairman who is always looking for ideas. Anne Katona was right. Education is our "job". So, when do we get started?"

I took just a couple of excerpts from the article. Funny how the more things change, the more they stay the same. We are the participants at dog shows and the educators of the judges at the same dog shows.





Journey to the AKC Therapy Dog Title

Cachet's Make No Mistake THD, our "Boo," became the third Kerry Blue Terrier to earn the THD (Therapy Dog) title in November, 2011. Here's how we did it.

While completing psychology graduate school 33 years ago, I handled and finished my first Kerry Blue Terrier, Riley. I thought then that living life with my Kerry Blue was limited to home and dog show grounds. My eyes were opened a few years ago when a psychologist colleague began bringing her Golden Lab to the office to be a therapy assistance dog. When the time came a few years ago to welcome a new Kerry Blue boy into our family, I was determined he would be my office partner too.

My wife and I welcomed 5 month old Boo on a Monday and he was in my office that Wednesday. He's been at my side in the office every day since.

Training

Boo and I are lucky to have access to weekly open obedience and handling classes. We started going to both, and soon enough, he'd mastered basic obedience commands, the first step to becoming a certified therapy dog and earning the THD title.

Kerry Blue Terrier Therapy Dog?

There are so many ways your Kerry Blue can share his or her healing gifts as a therapy dog. What moves you? What's the special magic and personality your Kerry has? After all, you and your Kerry each have particular passions to share!

Reatha Omodio takes her Kerry Blue "Becket" to a reading dog program. A second grader, at first skeptical about reading to a dog, revealed that it was so much easier to read to Becket because she listened so carefully and didn't correct reading mistakes! Nancy and McKenna Vance have written how their Kerry "Jack" has changed many lives, especially theirs, by serving in a hospice (see Nancy Vance's article in the July BluePrints).

Boo's a perfect Kerry for a psychotherapist's office. He's steady, alert, quiet, and perceptive. He knows

when to approach someone in distress or who would prefer he remain scarce. By nature, he's an emotionally reserved Kerry fellow. Depending on the situation, though, he offers up toys and occasionally insists on a game. He knows game times are to



be brief and gentle. Boo's great with infants and toddlers: he's sweet and curious and constantly checks in with me to be sure he's doing the right thing. If a mother is hesitant about having a dog around her newborn, Boo understands my cue to keep his distance. He's regularly borrowed by a psychologist colleague who works with an autistic adolescent who becomes so much more open and relaxed with Boo in attendance. We also regularly stop by to visit a nearby physician's office where Boo's a major hit with patients and staff.

Certification

Once you and your Kerry partner are familiar with basic obedience commands, then it's a good idea to read a pet therapy training manual or take a brief community workshop in pet therapy work. I ordered the student manual from Delta Society Pet Partners, but, I've since seen several community workshops and private classes offered. Contact a local AKC approved pet therapy organization (see the web link for a list). Therapy Dogs International (TDI) and Delta Society Pet Partners are the most well known, but, there are several, and the list keeps growing. I recommend you find one that's active in the community and convenient for you. Primarily, a pet therapy organization evaluates the temperament and training of your dog

and your skills as a handler. They also develop and nurture relationships with community organizations that want therapy dog services. Understandably, some places, such as hospitals, may have a few additional requirements beyond the pet therapy certification. For one nearby nursing home, I had to undergo a background check and TB test. Our local Children's Hospital requires a background check and additional evaluation around special medical devices. But, many other places will eagerly welcome you and your beloved Kerry Blue with few strings attached.

The evaluation process is straight forward. First, you, the handler, pass a simple written exam on therapy dog basics. You're asked easy questions like the difference between a service dog and therapy dog. Next, you make an appointment to be evaluated as a team. I was terribly nervous about this part, but the staff doing Delta Society Pet Partners: http://www.deltasociety.org the evaluations was very welcoming and helpful. Similar in feel and structure to the Canine Good Citizen evaluation, the pet team evaluators want to insure you and your Kerry can perform basic obedience commands and are going to succeed in a therapeutic environment. Our Delta Society Pet Partners evaluation was held in a hospital ward where, among other things, Boo showed he's unfazed around loud medical machines. Another task required that he ignore a treat left on the floor to prove he's trained to avoid picking up something like a discarded pill. He endured persistent groping. He gently took a treat when properly offered with an open hand. Being a Kerry Blue, he had the most difficulty being in the presence of another therapy dog. That day it was a Standard Poodle, and Boo was very curious about this other curly creature. Thankfully, he kept his curiosity mostly in check and we passed.

Boo had earned his vest and I.D. card! We could now officially volunteer as a pet therapy team. We've since gone on to visit some local nursing homes or spend quality time with stressed out students during finals week at a nearby university. Boo's most important Kerry Therapy Dog duty, always, is to be my therapy assistance dog.

To be awarded the AKC THD Title, your certified Kerry Therapy Dog is required to perform 50 hours of service as a therapy dog. Since Boo's at the office with me every day, it didn't take long for him to collect the necessary hours.

Therapy dog work is a hugely rewarding way to enhance the partnership with your Kerry Blue while also sharing that special Kerry spark with many eager souls in need. It's the best Kerry Blue Terrier outreach I've yet experienced. Many more people now know about and love Kerry Blues because of Boo's work. As for me, I get to take my Kerry to work!

WHAT'S WRONG WITH DOG SHOWS?

When I first started showing my wolfhounds, another exhibitor, who used a handler, told me if I wanted to win majors I was going to have to hire a handler. I replied, "If that's true, I'll quit, as there would be no point in showing."

Since that first wolf-

hound, I've bred and shown my own dogs and others to their AKC championships and to placements in specialties. I've trained others to show their own dogs and they have gone on to win group, BIS and specialty wins. The pleasure of owner-handling involves more than just winning. For most in the dog show world, it is a social event, a hobby that involves family members. It is a love affair with a breed, an outlet for stress and a way to enjoy doing things with your dog. Do you remember when you met friends at the show, put your xpens together for the dogs to play and you had a tailgate party? That's what more and more of us are saying..."Do you remember when?"

AKC has put out a moratorium on approving shows while they figure out why the big drops in entries. That's closing the barn door a little late. Breeder/owner handlers have been lamenting the situation for years, as more and more people dropped out, but no one "upstairs" has been listening. Sure animal rights movements, restrictive laws, and high license fees are hurting responsible breeders and the economy is taking its toll, but AKC is doing its part to discourage participation as well. If you live in New York City or large urban areas, you may have "too many shows" but if you live in an area like the panhandle of Florida, you will be driving over 3 hours to most shows and 8 hours to find a major! True. adding more shows hurts entries for long established shows but let's remember people who live in Hattisburg, MS will never have as many shows near them as people in Chicago do, and AKC should take that into account.

AKC needs to do more to get dog shows back into the realm of family sport instead of such a professional sport. Magazine features and televised shows seem to be all about who the handlers and long time breeder/handlers are... This year the Westminster newscaster (not the experienced judge-commentator) said, "...so it's all about the handlers in this (BIS) competition..." What does that project to novice handlers?

AKC has encouraged big money shows; they have allowed shows go to the middle of the week in clusters, great for professionals but not for what used to be the backbone of dog breeding – the smaller "dedicated-to-their-breed breeders" and owner handlers who have 40-hr-a-week jobs. When I

tried to discuss this with an AKC rep at our show, pointing out that the people showing their own dogs couldn't make the middle of the week shows, she gave me a cavalier, "Well, it's not a family sport" answer that reminded me of the alleged "Let them eat cake" remark by an oblivious queen that lost her head. She was pushing our club to move our show to a cluster farther south. How does that fall into serving our own community? What happened to you must give a show within 25 miles of your club's location? Who does it benefit having 4 shows in one location? First guess – those who don't have to move their set ups, not those living in the area.

When someone wanted our club to offer \$1000 for BIS to bring in more handlers, I turned to our catalog to prove to the board that the majority of dogs at our show were being shown by their owners. Over 56% of the entry had been shown by their owners or breeders. The board agreed to try it one time with the cash award and we got a total of 4 more dogs...the handlers were surprised when they got the checks... they didn't read the premiums and it wasn't why they had entered our show. It's the judging panel people are looking at when they check the premium.

In our area, 8 of the shows I used to attend are no longer held on weekends, cutting my showing and ability to find majors in over half while doubling my expenses. And at the rate show giving clubs are bleeding money, this trend will continue. Those dog clubs giving those independent shows will go under and as more of the smaller weekend shows disappear, the less the average exhibitor is able to continue going to all breed shows. Many influential breeders now just go to specialties.

While people like to think it is a myth that handlers can finish anything, many of us with enough years in our breed to know a good dog, know it isn't a myth. I've seen multiple specialty winners get beat by generic dogs under handlers. I recently attended a seminar where two judges said the advertising in show magazines have no effect. I work in marketing. Millions are spent on advertising and it isn't because it has no effect. If for no other reason than looking at the same winning dog in publication after publication fixes one's eye to that dog as what is correct, it is effective. Dogs that win in one area may not win in another area because the dogs they are up against look different, or the judge was mentored where different kennels with a different look are predominant. I once had someone ask me what was wrong with an Irish Wolfhound's topline because he was the odd man out in the line up - the only one with a slight curve over the loin. The onlooker thought it must be incorrect.

The same principle comes into play with weeklong clusters. Judges are seeing the same dogs with handlers constantly. The weekend warrior may have a dog that has won a specialty but he isn't out there constantly, and he is overlooked by judges that aren't totally up on that breed. When earnest breeders of good dogs begin to feel it doesn't matter how nice a dog they have when they are showing against heavily campaigned dogs or under judges not strong enough to put

Where Has Everybody Gone?



Here it is July and I've entered just 3 shows so far, one being my national and the other 2 were part of a 4-day cluster (no, no bad). Wow, doesn't that make me the weak sister of the show world! Or does it? That cluster had a whole lot of single dog entries with no points at all, and few majors. And it was one of the bigger shows in this latitude...so maybe what it makes me is part of a large family that's leaving home? Why? Well, I'd say from the responses to my previ-

ous article "Let Them Eat Cake," too many of them in this family are feeling like the proverbial red-headed stepsister being ignored by the head of the family, AKC.

The responses covered a lot of territory, but the problem of clusters was hitting everyone, and not just because handlers were getting more exposure and the inherent problems that brings. Far too many of us work and can't make up those lost weekend shows. One even pointed out that for a Jr. to compete nationally, she had to get out of school to compete at the clusters.

My show chair manual is a few years old, but I think it's still pretty much up to date. Under Show territory it says ... "a club is expected to hold its events within the fairly limited geographic area that the club has been placed on the records of the AKC. The area over which a club would be approved to hold events will depend upon such factors as the population of the area, breed popularity, other clubs of the same type in the general area, etc." Meanwhile in my 3 hour range since I started showing in this area, MBK – moved to Th-F, Biloxi MS (different state), Okaloosa, moved to Th-F to be part of 8-day show circuit that has fractured, Albany GA dog show gone, Panama City Dog show Th-F in Tallahassee, Montgomery AL dropped spring show, Tuscaloosa AL weekend in Montgomery - moving to Columbiana in spring - I've lost track of the LA club shows although at least one moved to Biloxi, MS and the one that was held in Dothan AL either died or went to Perry GA. So how many towns / cities/ counties are now being served by their local kennel clubs as far as bringing shows and exposure to all breeds to their area? Are all of these hardship moves or convenience clusters? How are the clubs going to survive as their memberships drop along with show entries? And since those clubs and volunteers put on the shows, how will those shows survive?

I was looking for something to bring home to my "dog sitter" and talked with one vendor who was sorely disappointed in the

sales at that show. She lamented the loss of people showing their dogs anymore and wasn't happy with sales during the week. Most of her sales were on Saturday, with people not buying on Sunday. Getting a good spot often requires a vendor to sign up for weekday shows of a cluster. She was joining the ranks of vendors that wouldn't be traveling to shows anymore. That led to a discussion on cluster shows. You would think vendors wouldn't want to have to pack up and leave a show site, but she expressed the same opinion I have on how they have been hurting the shows as well as her sales. It isn't just fewer exhibitors affecting her. Once an exhibitor has gone through the vendor booths, they aren't likely to go through again and they need the "fresh blood" a new site brings them. They are feeling the crunch of smaller shows too.

Many respondents felt AKC needed to hear us or continue to fall in numbers and influence in the dog world.

One good sign - a survey for show chairs reference some of the new AKC programs – the novice handler, owner handler only awards and now open shows. Having heard nothing but snide remarks about being thrown worthless bones that cost clubs money and how even the award of merit is seen to be backfiring as "pats on the head" for breeder/owner BIS/S winners while the handlers get BOB to send them to group with their campaigned dogs, it was hard to give them high grades. It would seem to rather endorse the perception of "give it to the professionals, we'll appease the masses with these other trinkets." Given the rise in UKC registrations and drops in AKC registrations, it is easy to see where the open show idea comes from. It is essentially a UKC format. No championship points but you earn certificates and you don't have to play with handlers... unless of course their name is on it, but it wouldn't be a big money game.

When our club first looked at the open show, we thought, isn't this the same as a match? Why would we spend as much putting this on as a show for fewer entries? But if AKC would let clubs piggyback the open shows on the regular shows? That might keep costs down and bring more owner handlers back. Would exhibitors return to the sport or stay for that? Why would it have to be an open show? Why not give shows that remain in their own areas and have less than 500 entries a break. (These shows are lucky to break even, but they pay a regular event application fee and \$1,750 in AKC per dog fees) Let them have a second show on at least Saturday, then maybe they could bring in more entries or save money on the site and expenses for an extra show. Clubs in close proximity could share the site and weekend the way they used to if there is a hardship with a site, yet both get the value of a weekend show. It's already being done with OB trials. Exhibitors are coming for 3 shots at earning a title in a weekend. Would exhibitors be more inclined to attend 3-4 shows if they could on one weekend? It saves gas and motel expenses yet just takes the weekend. The dog is already bathed and groomed. Not many judges at such small shows are filling their card unless there are only 3 judges and those shows go on until after 5 pm. Would you go for 2 shows and end at 8 pm?

I have returned to conformation showing and I am actively showing Kerry Blues and both Toy and Standard Poodles.

I am a full-time groomer and own multiple businesses: TCH Mobile Grooming, Low Country Grooming, and Low Country Kennels and my husband helps as much as possible when he is not traveling.



'Jack' has never met a stranger--just friends he hasn't met yet! He greets everyone with an entire body wiggle and sometimes his hindquarters arrive before his front, with nose to the air and his parting lips smiling at you as you pet him. He is the cuddliest of dogs and is happiest on your lap or in your arms. His love for life and people



make him an ideal family dog, and most recently, a stellar Therapy Dog.

'Jack' and McKenna began their therapy work when a volunteer from Hospice approached them and recruited the two for their budding program. We had been thinking of getting Jack involved in therapy as he seemed like such a natural for the work, but knowing others saw this attribute in him, made us excited to pursue this new venture. My daughter and 'Jack' have been volunteering their time visiting families in our tri-county area that are in nursing homes or are home-bound and under the acute care of Hospice. For these people and their families, their final days are generally full of pain, discomfort, sadness, worry, fear and uncertainty. I have been witness to their despair,

as life has beaten them down and what is left is just a shell of a person that once shined brightly and energetically. However, when 'Jack' visits, you can see that despair drain from their face the moment 'Jack' walks into the room and is quickly replaced by a bright smile, cheerful expression and rosy-complexion! Their depression is quickly replaced by renewed joy that once filled their lives previous to their terminal illness.

They hold 'Jack' on their lap, or he finds a vacant space on their bed...and some giggle when he hogs the space and gives them a gentle nudge with his nose to move over just a bit to give him comfort, too. He is very gentle and mindful of their medical needs and eerily seems to have the 'sense' to stay clear of their IV tubes and bandages. Many of our patients are battling cancer and their bodies outwardly show the scars of their fight for life, and 'Jack' will sniff and sometimes give a slow and gentle lick to their hands. He is not an outwardly intrusive dog, but rather shows interest and waits for the people to respond to him before he makes his next move. I have never witnessed such a beautiful relationship between dog and human. As some people are born to do great things, and I believe Jack was born to give comfort to those in their final days. And how blessed we have been to see his purpose in life be shared by those who need him so much!

Our most difficult experience was when 'Jack' was with his patient in her final hours of life. She had requested his presence as she passed and it was extremely difficult for my daughter and I to witness this once vibrant and beautiful woman, drift into a dark eternity. You see, Jack was her "teddy bear" dog and gave her comfort when she was called home. Some dogs have that sixth sense, and we witnessed this as 'Jack' gave her a gentle kiss on the hand as she drifted off, as if he knew she was leaving this world...

We have gotten letters from a few of the families we have visited, sharing their thanks and gratitude for being there during those final days. As humans, this gives us the satisfaction of doing something right in the world. Yet, to the beautiful KBT, they need nothing other than a scratch behind the ear or a kind word to keep them coming back for more! Although we wipe tears away constantly and have to stop and take a deep breath as we walk through the doorways, for we know what we are about to experience, 'Jack' continues to take charge by leading the way to greet new friends and share his love and cheerful disposition with anyone that will allow him to cuddle.

inner life of the youngster. It's clearly easier for many children to share themselves with a kind Kerry Blue Terrier than a human.

Boo's an incredible aide in assessing someone's mood. If a client is the least bit angry or threatening, Boo will lie down at my feet, seemingly in an effort to "keep the peace." He instinctively knows who's a "dog person" and who is not. For those rare visiting clients who have no affinity for dogs, Boo makes himself scarce. Nothing ever needs to be said or command given.

Sometimes, another colleague will bring in her Golden Lab girl, Molly, who's become Boo's big sister. They play together, and both go to greet people who enter the waiting room. And, always, when it's time to work, Boo knows, and quickly joins me in my office.

There's no mistaking that Boo is a Kerry Blue Terrier: he's loving, kind, clownish, and, (it's my responsibility to never forget) protective. Once, the UPS driver that comes to my office took the liberty of walking in and dropping a large parcel, causing Boo to go on red alert. All turned out just fine, but, that time required a command.

Outside our offices, he regularly shares his Kerry Blue Terrier personality, love, and laughs at a nearby Family Practice physician's office as well as a nursing home facility and some occasional special events where therapy dogs are requested. At the nursing home, special requests are often made for a "Boo visit."

lives. When she arrived
at 12 weeks old at the
San Francisco Interna-



tional Airport tail wagging as she came out of her travel crate and leapt into my arms, we just thought she was the most wonderful little creature we had ever met and felt very blessed to be in her presence.

Over the years, Toni became an integral part of our lives and grew to be extremely close to my husband. They have a non-verbal communication, one seems to know what the other is thinking or feeling. One fateful evening in March 2005, as I was soundly sleeping, Toni began pawing at my face and whimpering. I woke up thinking she needed to go potty, as I arose out of bed I found my husband, David, clutching his chest. I called 911 immediately! When the EMT's arrived they found my husband was in the clutches of a heart attack. If it had not been for Toni alerting me, my husband, very likely, would have passed away from his heart attack, as he was in such pain that he was unable to speak or wake me up.

Then, on April 3, 2010, while unloading our moving truck from our move to Arizona, Toni once again began barking, pacing and pointing me toward "Daddy". Again, my husband was transported to the Emergency Room. This time with Congestive Heart Failure. Is it a fluke or did Toni actually know something we didn't know? Well, maybe we could chalk it up to luck the first time, but certainly not the second time. Yet alone, a third time. In 2011 my husband told me that Toni is acting strange toward him. He said, "We need to go to the hospital. Toni is trying to tell us that something is wrong with me". So, we trusted our girl and went to the Emergency Room. Once again, Toni was right. My husband was developing another episode of Congestive Heart Failure. His ankles and legs began to swell and as we arrived at the Emergency Room he began having chest pains and was admitted to the hospital once again with Congestive Heart Failure.

So not only is Toni the love of our lives, but also the very reason my husband IS ALIVE. Toni celebrated her 13th birthday July 21 of this year. She is in good health but is on cancer watch due to a toe she had amputated a few months ago that was, indeed, malignant. However, she shows no signs of any further cancer.

Toni is not only a life saver, but an exceptional ambassador for the Kerry breed. People who have met Toni have themselves decided to get a Kerry solely based on her attitude and loving personality.



A Word from Charitable Funds...

As many of you know the US Kerry Blue Charitable Fund was established in 2002. Its purpose was to serve the Kerry Blue Terrier in four important areas:

- 1) **Rescue Fund** this fund supports grants used to provide Kerry Blue Terrier rescue services.
- 2) Health and Genetics Fund this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier.
- **3) Education Fund** the education fund supports education of all those interested in the Kerry Blue Terrier including publications, websites, and seminars.
- **4) General Fund** donations to this fund are used to support the work of the other funds through internal grants to those funds. Undesignated gifts will initially be held in this fund.

The USKBTC currently has two testing requirements for CHIC certification: Hip dysplasia/OFA and CERF (eyes). Three tests are optional: Factor XI (blood clotting defect), von Willebrands Disease (blood clotting defect), and Degenerative Myelopathy.

If you plan on breeding a bitch, or using a male for stud service, these are tests which you should consider performing in part or in entirety. OFA hip dysplasia certification is strongly recommended-Kerries can develop hip dysplasia. CERF testing for eye defects is good to do to try to prevent any ocular defects from starting up in the breed--CERF testing is usually not expensive, and can often be done a breed/all-breed club sponsored health clinic. The two blood-clotting disease tests should be done is there is any history of blood -clotting problems in the pedigrees of dogs that are going to be bred, or if you have a stud dog that is being used often. Degenerative myelopathy testing should be used to try to avoid development of the disease later in a Kerry's life.

Carrier status and positive status Kerries should be bred to negative status Kerries. The objective is to produce only negative or carrier status Kerries and to avoid positive Kerries. Kerries that test positive on the DM test can develop the disease at some point in their lives (usually at an elderly age), but often they die from some other cause before DM ever is developed.

For all Kerries in general, it is good to start yearly blood chemistry testing/complete blood counts at 8/9 years of age. Any kidney/ liver/other abnormalities are good to detect early in the disease process. Be sure to test for heartworm, and Lymes Disease (in Lymes areas). Thyroid testing is suggested for dogs that show clinical signs. Chronic diarrhea/vomiting, increase water intake/ urination, respiratory abnormalities, chronic coughing are all indications to have your dog seen by your veterinarian. Kerries and terriers often don't show illness early on--if they are acting sick, there often is something wrong.

The keys to managing degenerative myelopathy

The spinal disease robs large breeds of the ability to walk and run

■ Degenerative myelopathy is a devastating disease of large breed dogs, often in the prime of life, that can rob them of their ability to run and walk. But a growing understanding of genetics could lead eventually to an ability to identify dogs prone to the disease and avoid breeding them.

Degenerative myelopathy is a gradually progressive disease seen quite commonly on the neurology


service, says neurologist Philip March, DVM, at Cummings School of Veterinary Medicine at Tufts University. "It is not a fatal disease, but once large breed dogs are paralyzed in their rear legs, it is difficult to manage them."

The cause of DM is not known. For reasons yet to be determined, nerve fibers or "axons" in the spinal cord begin to degenerate. The process starts in the thoracolumbar region of the spinal cord — the middle of the back — affecting the axons that connect the brain to the rear legs.

Although a canine gene mutation linked to DM has been isolated — in the gene that codes for superoxide dismutase, or SOD1 — this finding may not be as significant as had been hoped. Several other mutations are likely to contribute to the onset of the disease with the SOD1 gene mutation probably playing a relatively minor role.

Excitement dimmed

There was some excitement in the veterinary community when the link between DM and the mutated SOD1 gene was announced in 2008. The fact that the mutation has also been linked to a degenerative nerve disease in people (amyotrophic lateral sclerosis, or Lou Gehrig's disease) has drawn public attention. However, the disease in dogs affects very different neuroanatomical pathways than the more common type of ALS in humans, Dr. March says. For this reason, the clinical signs of the two diseases are difficult to compare. "Although the SOD1 mutation has been identified in dogs with DM, it is only one risk factor for the disease, and there are likely multiple genetic factors that combine to

produce the spinal cord degeneration seen in DM," Dr. March says. "It is clear that we don't fully understand all of the genetic factors at this point."

The SOD1 mutation does appear to be widespread across several breeds of dogs affected by DM. Even though this mutation may not be the primary cause of DM, Dr. March recommends that breeders test their breeding stock and their offspring for this mutation. In this way, he says, "The genetic test can be useful to breeders who want to avoid perpetuating a higher risk for DM in their lines of dogs."

DM is reported most commonly in German shepherd dogs but is also prevalent in Pembroke Welsh corgis and boxers. The disease occurs less frequently in other large breeds such as the Rhodesian ridgeback, collie, standard poodle, Irish setter, Chesapeake Bay retriever and Bernese mountain dog. Small breeds other than the Pembroke Welsh corgi are typically not affected. The average age of onset in large breed dogs is about 8 years of age. In corgis, the average age of onset is about 11 years.

Chronology of signs

The signs of DM typically come on very slowly and worsen over 6 to 12 months before dogs can no longer support weight in the rear legs, though the progression can vary among individuals. The signs show a characteristic sequential pattern with this chronological course:

- "Scuffing," or knuckling over of the toes in the rear legs
- Incoordination in the rear legs
- Difficulty rising and climbing stairs

Staggering and falling

 Weakness in the rear legs progressing to inability to bear weight and eventual paralysis

By 10 to 12 months after the onset of signs, most dogs are completely down in their rear legs and can no longer stand. Dogs at this stage will still have front leg strength and can use their front legs to drag themselves for short distances. Urinary and fecal incontinence do not develop for several months to a year after loss of the ability to walk.

Surprisingly, the disease itself is not painful, but because the back legs often splay out from weakness, affected dogs are more prone to develop muscle strains. Anti-inflammatory drugs can help the discomfort from these secondary injuries and also ease the arthritis that many older dogs may have, Dr. March says. "Dogs with DM lose the sense of where

their legs are in space and eventually lose their ability to move the legs, but they retain the sensation of pain from other sources such as muscle strain injuries or arthritis."

Tentative diagnosis

The diagnosis of DM is tentatively made by ruling out other causes of slowly progressive rear leg weakness. The most common causes of these signs are a slowly protruding herniated disk or a slowly growing spinal cord tumor.

"By gradually compressing the thoracolumbar spinal cord over time, a protruding disk or a growing spinal cord tumor can cause clinical signs that mimic those of DM," Dr. March says. "These conditions will result in visible spinal cord compression on an MRI, whereas DM is characterized by no visible abnormalities on MRI. Fiber degeneration due to DM is at a microscopic level, and MRIs are not sensitive enough to reveal this degenerative change."

Unfortunately, compressive disks or tumors will not show up on an X-ray. Veterinary neurologists use more advanced imaging, such as MRI, to rule out these disorders. Dr. March cautions referring veterinarians and owners that MRI or other advancing imaging should not be delayed if early signs of rear leg problems are observed. The reason: "Disks or tumors that compress the spinal cord for prolonged periods - weeks to months - will result in irreversible degeneration of the spinal cord with irreversible signs to the back legs. If the compression is relieved surgically at an early stage, irreversible spinal cord damage can be avoided and the long-term outcome will be much better."

Dr. March also cautions against using the genetic test for the SOD1 mutation as a diagnostic test for DM.

The DM blood test provides information about only one risk factor for DM in dogs. A positive test indicates that a dog is at risk for developing DM, but many dogs showing positive on the test will never develop DM. For this reason, veterinary neurologists do not rely on this test to diagnose a case of DM — MRI is still recommended as the current gold standard for diagnosing DM.

Currently, there is no effective treatment that will reverse the signs of DM in dogs. Multiple therapies have been attempted in dogs, such as acupuncture, nutraceuticals and anti-inflammatory medications, without any proven benefit. Despite the fact the SOD1 mutation results in a deficiency of an antioxidant enzyme, antioxidant therapies such as vitamin E, vitamin C and SAM-e - have not been effective in DM. "Once a more clear picture of all of the factors that lead to this disease emerges, a more rational and directed treatment approach may have a better chance of success," Dr. March says.

Exercise may help

Supportive care such as exercise and physical therapy may help slow the disease's progression. A recent study in a small number of dogs has shown that during the

moderate stages of the disease, short but frequent exercise may be beneficial. Walking a dog for 5 or 10 minutes at least five times a day helps maintain muscle mass in the back legs and increases circulation. "Exercise also makes the dogs feel better," Dr. March says. "It gets them up and around and boosts their spirits."

Some experts advocate alternating exercise with physical therapy to maintain joint flexibility and muscle strength. They also encourage massage and treadmill hydrotherapy. The underwater treadmill is especially helpful, Dr. March says. "While the dogs are getting exercise, most of their body is underwater so they can bear weight more easily."

Meticulous at-home care is necessary to keep the dogs clean, dry and comfortable. Dogs can develop urine scald, similar to diaper rash of the skin, as well as frequent urinary tract infections. Padded bedding at all times will help prevent bed sores. When dogs with DM reach the point of being down in the rear legs, Dr. March says that, "Bacteria in the environment can enter the urinary bladder and cause signs of recurrent urinary tract infections. The bac-

teria can get very resistant to antibiotics over time, and the infections can be very difficult to treat."

Maintaining mobility

One of the biggest problems owners face in coping with large dogs suffering from DM is moving them from place to place. Among the advances in mobility equipment that Dr. March cites are modified slings that loop under both back legs and the groin area.

"With handles for the owners to

grab on to and hoist the dog up from a sitting posture, they will often work for any breed," he says. One recommended brand is the Help 'Em Up Harness.

Carts have long been helpful in providing mobility for both large and small dogs with rear limb paralysis. However, large dogs can

be hard to hoist in and out of the carts, and the carts themselves can be difficult to use in the house. Dogs have trouble negotiating the cart around corners, around furniture and in tight spaces.

In addition, while dogs can urinate and defecate in some carts, they often refuse to do

so because it feels quite awkward. Because of this, owners are advised to manually support their dog to urinate and defecate outside before they place them in the cart.

Some dogs may not adapt to the cart and if loss of mobility, recurrent urinary infections and general debilitation become evident, the difficult option of euthanasia must often be considered for severely disabled dogs.

Despite the lifestyle changes that DM imposes for both dogs and owners, many owners believe that as long as their dog enjoys the everyday pleasures of being a dog, quality of life can continue to be quite good. Says Dr. March: "Many dogs with DM adjust to the cart and appear quite invigorated by the opportunity to walk and run on their own again."







Cold Weather Canine Care Tips

A dog's need for food, shelter and loving care increases during the cold winter months. Keep your dog safe and warm by following these guidelines.

- Dogs can get frostbite or hypothermia when temperatures drop. Don't leave your dog outside in the cold for long periods of time. Provide a covered shelter, such as a doghouse or kennel, for the times the dog is out of doors.
- When your dog is inside, keep him warm, dry and away from drafts. Tiles and uncarpeted floors may become very cold, so put down blankets or pads for him to lie on.
- Keep your dog a safe distance from supplemental heat sources such as portable heaters and fireplaces, which can cause severe burns. Place screens around fireplaces.
- Don't leave your dog alone in a car on cold days.
- Feed your dog additional calories, particularly if it spends a lot of time outdoors or if it is a working dog. The extra calories are necessary because it takes more energy in the winter to regulate body temperature.
- Provide plenty of fresh water at all times. Dogs are just as likely to get dehydrated in winter as in summer. Snow is not a good substitute for water.
- Groom your dog regularly. Your dog needs a wellgroomed coat to keep properly insulated. If you have a short-haired dog, consider a sweater or coat. If your dog is long-haired, clip the hair around its paws to ease snow removal.
- Dry your dog with a towel or blow-dryer if it gets wet from rain or snow. Clean snow and ice from its paws to prevent cuts and cracked pads. A little petroleum jelly may help soften and soothe paw pads.
- Be extra careful when walking or playing with your dog near frozen lakes, rivers or ponds. Your dog could slip or jump in and be seriously injured.
- Rock salt, used to melt ice on sidewalks, can irritate paw pads. Rinse and dry your dog's feet after a walk.
- Watch out for spilled antifreeze on driveways.
 Antifreeze smells and tastes good to dogs, but it can be lethal.
- Dogs, like humans, seem to be more susceptible to illness in the winter. Take your dog to the veterinarian if you notice any signs of illness.

- 2. Thirty (30) days after publication in BLUEPRINTS, your application and any member's comments will be submitted to the Board of Governors for consideration.
- 3. You will be promptly notified, in writing, of the Board's action.
- 4. You will be provided with a copy of the approved Constitution and Bylaws.

This Membership process can take up to six (6) months or more, due to the Quarterly publication of BLUEPRINTS, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership, your application fee will be refunded.

THE UNITED STATES KERRY BLUE TERRIER CLUB CODE OF ETHICS

This document defines the ethical standards to which we ascribe as a condition of membership in the United Stated Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

I. RESPONSIBILITIES AS A MEMBER

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemperhepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

IV. ENFORCEMENT

- > The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
