# Revised USKBTC Rescue Policy

# **PURPOSE**

To provide for the rescue of Kerry Blue Terriers in areas of the country where there is no Chapter Club rescue service available, to coordinate and assist Chapter Club rescue efforts, to assist members who breed in recovering and re-homing their dogs, and to provide rescue liaison with other clubs and organizations.

# DEFINITION OF TERMS Rescue Dogs

Kerries requiring rescue from shelters or from similar, potentially life-threatening situations, including stray dogs, owner-relinquishments, dogs abandoned at a vet or boarding kennel, and dogs whose owners are dead or disabled. The United States Kerry Blue Terrier Charitable Funds may cover all expenses involved in rescuing these dogs; however, no funds can be used to purchase dogs from pet stores, puppy mills, brokers, or from their breeders or owners.

# Individual Rescue Dogs

Kerries recovered by individuals, normally USKBTC club members, who wish to foster the dogs and place them on their own. USKBTC Rescue Funds may be used to reimburse individual rescuers for some or all of the expenses involved in the rescue, provided that the individuals follow all USKBTC procedures for placing these dogs.

# Individual Placement

The placement of Kerries in need of new homes who reside with their owners or are being re-homed by their breeders. These dogs are not "rescue dogs," since they do not require rescue as defined in this document. The owner or breeder assumes the responsibility of caring for and placing the dog. While the USKBTC may offer assistance in finding homes, there are no Rescue funds designated for these dogs under normal circumstances. However, in cases where the owner or breeder indicates their intention to relinquish the dog, a Rescue volunteer may take possession of the dog, and the Kerry will then be treated as a rescue dog and evaluated as such to determine the best course of action.

# Breeder/Co-Breeder

The person(s) responsible for originally producing and/or placing the dog, normally the person(s) listed as the breeder/co-breeder of record including the owner/co-owner or lessee(s)of a dam who takes a puppy from a litter as part of a contractual obligation or in lieu of payment

# Stud Dog Owner/Co-owner

The owner(s) or lessee(s) of the Stud Dog (sire) of a litter on the date of mating which produced a litter including any owner/co-owner who takes a puppy back as part of a contractual obligation or in lieu of payment

# Spring 2008

The Owner/Co-Owner or lessee(s) as reflected on the dog or bitch's record of registration, including any Owner/Co-Owner who places a dog after retiring it from showing or breeding.

If a breeder, Stud Dog Owner, Owner/Co-owner or lessee or other responsible party is a USKBTC member, they assume lifelong responsibility for the dog, including taking the dog back as needed.

# Rescue

USKBTC members who have volunteered or who are asked to assist with any aspect of rescue. Efforts are coordinated and controlled by a National Rescue Coordinator appointed by the board of governors of the USKBTC. The USKBTC Rescue Coordinator will keep the most current version of the USKBTC Rescue Policy on file, and shall make it available to all volunteers and other interested parties.

# RECOMMENDED RESCUE PROCEDURES RESCUE DOGS Shelter Kerries

Because the USKBTC has no claim to these dogs prior to their release, no mention of the location or existence of a Kerry in a shelter is to be made to anyone not directly involved in the rescue, particularly to someone inquiring about obtaining a rescue Kerry, until the dog has left the shelter. A Rescue Coordinator may direct breeders to make discreet inquiries to past puppy buyers concerning the current status of their Kerries, if they believe they can identify the dog or its owner.

As soon as a Rescue Coordinator is notified, arrangements should be made for a Rescue Committee member or another breed knowledgeable person to visit the shelter and confirm whether or not the dog is actually a Kerry. If the dog is a Kerry, an information packet should be left with shelter personnel in the event that the dog is claimed by its owner or adopted by another party. A Rescue Coordinator should obtain all the information necessary to claim the dog, including when it will be available for adoption and what the shelter's policy is in the event that more than one party wishes to adopt the dog. Provisions should then be made for grooming, veterinary care (including spaying or neutering, if needed), and foster care.

If the dog has not been claimed, at least two Rescue Committee volunteers, if possible, should be at the shelter as soon as it opens on the first day the dog is made available for adoption. If another party is considering the dog, a Rescue Committee member talk to the party about their interest in the dog, offer the USKBTC 's assistance, which may include allowing the party adopt the dog through USKBTC Rescue, and try to obtain their name and address. In the best interest of the breed and the rescue, all shelter rescues and encounters with other rescue organizations or individuals should be polite and nonconfrontational. Unless a Rescue Committee member

has a very good reason to suspect that the party is not there for legitimate reasons (such as a dog collector, backyard breeder, or broker), the party will be permitted to adopt the dog with our blessings. If the Rescue Committee member can provide evidence of their suspicion, it should be provided to the shelter or the authorities. Regardless of whether Rescue claims the dog or not, a thank-you note should be sent to the people who contacted Rescue about the animal.

If Rescue adopts the dog, the dog will be taken to a veterinarian as soon as possible, and before being exposed to other dogs or taken into foster care. The dog's general health and age will be assessed, and the dog will receive all recommended vaccinations, fecal exam, a complete blood chemistry panel to include tests for heartworm, thyroid (T3), leptospirosis, and brucellosis, and any recommended treatment and medications. The dog will be checked for the presence of a microchip or tattoo, bathed, and groomed as soon as possible. Tattooing or microchipping the dog for permanent identification purposes will be done prior to placement. The dog will be assessed both physically and for temperament before being placed. Every effort will be made to identify and locate the breeder and/or owner. If the breeder or owner can be positively identified, he/she will be asked to reimburse any costs, such as shelter fees and veterinary care, related to the rescue. If the breeder is a member of the USKBTC, our Code of Ethics requires that he/she will accept responsibility. The owner of the sire may also be contacted and offered the opportunity to take possession of the dog or otherwise assist in the placement.

The USKBTC takes great pride in the fact that the majority of its breeders abide by our Code of Ethics and will rehome dogs they have bred. Unfortunately some don't. As a result, any person who refuses to accept responsibility for a dog that they bred/co-bred or placed (e.g., stud fee puppy or puppy back) will have the dog's name and registration number, if known, published in Blueprints and on the Club's website. The breeder or other responsible party, if a Club member, will no longer be able to list pupples or mature dogs for sale on the USKBTC web site.

If the breeder of the dog is a USKBTC or Chapter Club member, and can be identified, the dog will not be released for adoption until the breeder is notified and given the opportunity to take the dog back themselves or make other arrangements for its care and placement. Breeders who are not members of the USKBTC or a Chapter Club may be notified and offered their dogs back at the discretion of the Rescue Coordinator; however, this is not required. If the breeder cannot be identified during the evaluation period, the dog will be assumed to be bred by someone who is not a US or Chapter Club member, and will be spayed or neutered prior to placement through Rescue.

# Owner Relinquishment

If an owner contacts Rescue about giving up their Kerry, every effort will be made to talk to the owner and find out exactly what the problem is. The owner will be advised to try contacting the breeder, but if the breeder is unable or unwilling to help, reasonable assistance will be offered to resolve problems with training, health issues, or grooming to try and keep the dog out of rescue. If the owner insists that he/she is unable to keep the dog even long enough to locate a new home, or threatens to leave the dog at a shelter or have an adoptable animal destroyed, arrangements should be made to obtain the dog, along with its registration papers and health records. The owner or a person representing the owner should be asked to sign a surrender agreement, acknowledging that they are giving up all rights to the dog, before Rescue accepts possession of the dog. A donation to Rescue may be requested from the owner to offset the cost of fostering and placing the dog, but should not be a condition for accepting the dog. The breeder, if different than the owner, should be notified as soon as possible and the dog will be treated as a Rescue dog.

# Kerries Surrendered or Abandoned Due to Owner's Death or Disability

Rescue should obtain registration papers and health records, if available, from the owner or next of kin and contact the breeder. All other procedures are similar to those for shelter or owner-relinquished Kerries.

# Stray Kerries

If USKBTC Rescue is contacted about a suspected Kerry that is running loose, Rescue should try to send at least one person familiar with Kerries to the area as quickly as possible to try to capture the animal. If somebody has already confined the dog, arrangements should be made to pick up the dog at the convenience of the person who has the dog. Every effort should be made to locate the animal's owner, including checking local newspapers, placing an ad, checking with nearby shelters and veterinarians, and notifying breeders. The dog should be checked by a veterinarian as soon as possible and groomed as stated for a shelter Kerry; however, spaying/neutering and placement should be delayed for 30 days in order to give the owner a reasonable period of time to claim the dog.

# Kerries Abandoned at Veterinarians or Boarding Kennels

Rescue should try to contact the owners of the dog to find out why the dog was abandoned, to ask that they contribute to the costs incurred, and to request that they turn over registration papers and health records to Rescue. The dog's breeder, if known, will also be contacted. It is recommended that Rescue obtains the owner's (or his agent's) signature on a release form. If this is not possible, the dog should be held for 30 days from the date it was originally abandoned or surrendered, before it is placed. Once the dog has been obtained by Rescue, treatment is similar to that of a shelter Kerry except that some veterinary tests, particularly brucellosis, may be

omitted if the dog is healthy and its background, or medical records are known.

# Individual Rescue Dogs

Rescue may offer assistance to the rescuer in the form of (1) financial reimbursement for the rescue if all USKBTC Rescue procedures concerning screening and placement are followed, (2) a list of prospective homes-both screened and unscreened (with the understanding that the person placing the dog will do the screening), (3) a placement questionnaire for screening, and (4) an adoption contract. If the rescuer is cooperative, he/she acts as a Rescue volunteer, but wishes to retain some control over the dog's fate by doing the fostering and making the ultimate placement decision. Correct procedure depends on the circumstances of rescue.

# Individual Placement

Rescue may assist USKBTC members with placement referrals for adoptable older pups and adults. No liability may be assumed; USKBTC Rescue paperwork will not be used in these cases; placement and responsibility lie with the breeder and/or owner. This is not a referral service for breeders looking to sell young puppies or show prospects; these dogs must be spayed/neutered before placement. A donation may be requested from the breeder/owner for successful placements.

# Pet Store Puppies

Under no circumstances will Rescue "rescue" puppies from a pet store by purchasing them. Buying the puppies could motivate the store to try to obtain more. A Rescue volunteer may leave information packets at the pet store, one for each puppy, which include phone numbers of people who can assist. The packets are to be given to people who buy the puppies. The Rescue volunteer should try to see the puppies' registration papers, and note the name of the breeder. Periodic calls or visits to the pet store may be made to check on the puppies' status. All contacts with the store should be friendly, polite, and non-confrontational; however, no offer or agreement should be made to groom, trim, set ears, or do anything else that would make the puppies more appealing and therefore easier to sell. Under no circumstances will Rescue funds be used to purchase Kerry Blue Terriers from pet stores, auctions, or directly from their owners or breeders.

# **Advertised Dogs**

Rescue should scan ads in area newspapers, community bulletin boards, and other public places, as well as ads appearing in magazines such as *Dog World*, when possible, to determine if the advertiser of a Kerry is a USKBTC or Chapter Club member. Although many responsible breeders advertise litters, it's the backyard and commercial breeders' puppies that typically end up in rescue. Any information that can be obtained about these breeders and their dogs will be kept on file and the breeders of the litter's sire and dam, and the owner of the sire (if dif-

ferent from the breeder) will be notified if they are USKBTC or Chapter Club members. Counter-ads may be placed and paid for out of Rescue funds at the discretion of the USKBTC Rescue Coordinator or local Chapter Club.

# Special Cases— 1. Mistaken Identity

Homeless dogs, particularly those picked up as strays, are sometimes misidentified as purebred Kerry Blue Terriers, usually by well-meaning volunteers who are unfamiliar with the breed, and sometimes by Rescue volunteers who are initially confused by the dog's shaved or matted coat and only realize their mistake after they have taken the dog. These situations need to be handled carefully, since we do not want to alienate shelter workers or other rescue volunteers and discourage them from contacting us in the future. If a Rescue volunteer determines that a dog is not a purebred Kerry before we accept possession of the dog, the people who have the dog should be politely informed of their mistake and perhaps a more suitable identity can be suggested. However, if a Rescue volunteer realizes a dog is not a purebred Kerry until after we have it, the USKBTC Rescue Coordinator will determine whether we place the dog ourselves, turn the dog over to another breed rescue, or take another course of action. Under no circumstances will a dog be returned to a "kill" shelter.

# 2. Boarding Owners' Dogs

Rescue is occasionally contacted by people looking for someone to keep their dog for them while they are moving, on vacation, experiencing family problems, etc. Due to a shortage of qualified foster homes and the fact that these situations usually require someone to keep the dog for several weeks or longer, or even indefinitely, we will not keep dogs for their owners, or help with boarding expenses. Rescue volunteers may suggest that the owner check out local boarding kennels or petsitters for discounted long term rates, or contact the dog's breeder for assistance. If this is not possible, the owner may relinquish the dog to Rescue for fostering and placement.

# SCREENING AND PLACEMENT PROCEDURES

To ensure that dogs handled by Rescue are appropriately placed in responsible, permanent homes, and to protect the USKBTC from any liability in the event a dog with health or temperament problems is placed, a formal screening and adoption process must be followed.

### **Fostering**

A minimum two-week foster period is required in order to objectively evaluate a rescue Kerry's temperament and health, and to determine the most suitable placement. The USKBTC considers fostering and adoption to be two separate processes and does not encourage "foster to adopt" arrangements. Potential adopters should be advised that fostering is normally done by USKBTC members who are familiar with the breed, and is not a way to expedite an adoption. A copy of the current Foster Agreement should be signed by the foster family and kept

# Adoption Application

All parties expressing interest in adopting a Kerry through Rescue need to submit a completed adoption application. References will be checked by a Rescue volunteer and a home visit will be conducted before a prospective adopter is approved. An adoption application can be downloaded off the Club website or mailed to the interested party, with an information packet (if they have never owned Kerries).

Any person fostering a rescue Kerry, will do their best to assess the dog's temperament and personality, and determine what kind of a situation that particular dog would do best in. Possible adoption applicants can then be contacted. While some preference will be given to people who live in the same state/region as the foster home, have been on the placement waiting list longer than others, or have expressed extreme interest in a particular dog, the dog's best interests must always come first. The USKBTC Rescue Coordinator will make the final decision on who gets a rescue dog. In cases of individual placements and individual rescues, the owner, breeder, or individual rescuer will make the final decision. A "cool down" period of a least one week is recommended between the times that the potential placement is first contacted about the Kerry or has met the dog and the time that they are allowed to take it home.

# Adoption Contracts

Adoption contracts for all rescue dogs must be filled out and signed before the new owners can take possession of the dog. A Rescue volunteer will review the contract with the dog's adopters, emphasizing that the dog must be returned to Rescue in the event they no longer wish to keep it. Any known health or behavior problems that the dog might have will be listed on the contract. A donation to the USKBTC Rescue Fund through the US Kerry Blue Terrier Charitable Fund is normally required, although a Rescue Coordinator may allow an exception in certain cases. The actual amount of the donation depends on the overall adoptability of the dog; i.e., a higher donation will be requested for young, healthy dogs than for dogs whose age, health, or other issues make them less desirable as pets. Adopted dogs should go to their new homes with at least one week's supply of the dog's regular food, a leash and collar, and any toys, bedding, medications, etc. that belong to them. Adopters will also receive any health records on the dog, but are not to be told any information about the dog's pedigree, or the identity of the breeder or previous owner(s). Any registration papers will be returned to the AKC, marked "VOID, dog placed through United States Kerry Blue Terrier Club Rescue."

### Euthanasia Policy

Euthanasia may be required in certain cases where, due to health or temperament problems, a dog is unadoptable. Generally, the only cases where euthanasia will be considered are when the dog has a history of bit-

ing, exhibits aggressive behavior indicating that it will bite, or has health or temperament problems that make it unadoptable or that profoundly affect its quality of life. Advanced age alone is not a justifiable reason to euthanize a dog. If a dog is considered a candidate for euthanasia, the option will be discussed between the foster family and the Rescue Coordinator. A veterinarian or other professional, such as a dog trainer, should be consulted before a final decision is made. A consensus between the foster family and the USKBTC Rescue Coordinator must be reached before the dog can be euthanized. If a consensus cannot be reached, the issue will be brought up for a vote with the board of the USKBTC.

# Rescue Volunteer Responsibilities

It is understood that Rescue volunteers and Coordinators will fully cooperate with the USKBTC and participating Chapter Clubs in sharing information about rescue dogs and the names of potential adopters, offering any other assistance when requested, and requesting assistance if needed, to facilitate the rescue and placement of Kerries anywhere in the United States. It is also understood that when a conflict occurs between another organization's rescue policy and the USKBTC's Rescue Policy when dealing with a Kerry Blue Terrier, members of the USKBTC are required to adhere to the USKBTC Rescue Policy. Chapter Clubs are expected to deal with rescue situations within their territories, as defined in their bylaws, and are encouraged to assist in adjacent areas as they are able. Each Chapter Club is encouraged to designate one or more members as its Rescue Coordinator, and provide this person's contact information to the USKBTC Rescue Coordinator to be included on the USKBTC website. In the event that a Chapter Club does not designate a Rescue Coordinator, the Chapter Club president's contact information will be listed instead. Any USKBTC member who has any knowledge whatsoever of a Kerry in need of rescue or re-homing, whose breeder is also a USKBTC or Chapter Club member, is encouraged to notify that breeder of the dog's situation, and support and supply reasonable assistance to the breeder, so that the breeder's obligation can be fulfilled.

The USKBTC Rescue Coordinator shall maintain a list of USKBTC members who are willing to serve as Rescue volunteers, as well as the names of Chapter Club rescue coordinators. Chapter Club Rescue Coordinators are encouraged to coordinate their own Club's Rescue efforts with those of the USKBTC and to follow USKBTC Rescue policy.

In addition to adhering to all portions of this Rescue Policy and assuming all responsibilities stated in the policy, the USKBTC Coordinator shall be responsible for keeping an up-to-date file on rescue cases, the current whereabouts of placed rescue dogs, and a list of screened potential homes. The Rescue Coordinator shall also be responsible for seeing that follow-up calls are made to all adopters to ensure that the placement is working and to

# Rescue News

The 2007 AKC Parent Club Conference The AKC Parent Club Conference, held this past July in Peachtree City GA, covered a number of topics of interest to Parent and Chapter clubs, and their members. The seminar focusing on Rescue was titled, *Breed Rescue: Potential* Liability and How Best to Avoid It. This topic applies not just to Breed Rescues, in my opinion, but to anyone selling or placing dogs. The presenter, an attorney specializing in dog law, advised Breed Rescues to familiarize themselves with the legal implications of terms such as "negligence" (failure to use a reasonable amount of care), "negligence per se" (an action that breaks the law or violates common sense), and "vicious propensities" (which can include behaviors not normally considered vicious. but that result in injury, such as jumping up or chasing). In order to protect themselves and their members from liability, she strongly recommended that all dogs coming into Rescue be thoroughly evaluated prior to placement to determine their temperament and habits, and that adopters receive complete disclosure. Use formal paperwork, don't cut corners when evaluating and placing a dog, have liability insurance (which the USKBTC does), and never place a dog that you know might injure somebody. In other words, everything that's already covered in our Club's current Rescue Policy!

Having participated in breed rescue since 1993, fostering and placing 10 Kerries myself so far, and being involved in the placement of many others, I know firsthand how inconvenient this process can often be. And I fully understand how tempting it is to do placements by referral (putting potential adopters directly in touch with the current owners or shelter) or "foster-to-adopt" instead. But, as some of the following recent Rescue cases illustrate, we can't afford to take shortcuts! Club members need to adhere to the procedures described in our Rescue Policy in order to protect themselves, the Club, the new owners, the dogs, and the breed's reputation.

### Recent Rescues

After some false starts, *Molly*, the Oklahoma Kerry I took in for fostering in August, finally got placed in February. Two people she was initially promised to got cold feet and backed out at the last minute, while a third sounded almost too good to be true...and was: a home visit revealed that she, in the words of a nearby Club member, was telling us exactly what she thought we wanted to hear! But everything worked out for this sweet little girl in the end, and Molly went to a family exactly like what I had originally envisioned as the ideal placement for her. Thank you, Gigi Reilling, Tia and Ron Hewlett, Anne Marie Flynn Fierke, Tom Rogers, Stephanie Mastorakis, Dick Schaefer, Nancy Robards, Lois Croley, Charlene Dwyer, Lynn Duckett, Janis Whittier, and everyone else who helped make Molly's story a happy one.

Molly was bred by a USDA Class A licensed commercial breeder (i.e. puppymill) in lowa, and has a microchip that was not registered but was part of a lot originally purchased by the Hunte Corporation.

Honey was a New Year's resolution of sorts: namely the wife resolving to make her husband get rid of his nine year old Kerry. She asked us to "rescue" (her words) their dog, insisting that having her around their 5 month old baby was "unsanitary." Turned out she was telling the truth on both counts--the poor thing was filthy and neglected, and her eyes were so glued shut from mattered hair that she could barely see! There were many people involved in Honey's rescue and placement, but the lion's share of the credit goes to Janis Whittier and Mary McGreevy for evaluating, transporting, and grooming Honey, and especially for finding a home for her; Mary's aunt and uncle, Marilyn and Frank Cavallaro, for fostering Honey; and Dr. Scott Kellogg for the discounted spay, testing, dental cleaning, and other badly needed veterinary care. Also thank you to Gerry Yeager and Jim Cox for doing home visits. Honey is now living with a retired couple who wanted an older dog to keep them company. According to Mary and Janis, the family was pleasantly surprised by how young a 9 year old Kerry Blue looks and acts!

We did not get any papers with Honey, but the owner said he purchased her as a puppy from a breeder in Wheaton MD.

Gigi Reilling deserves all the credit for fostering and placing *Cash*, a young adult male rescued from a Missouri shelter. She did the same thing with another shelter rescue, *Josh*, a little over a year ago, even taking him back and finding another home for him when his first placement didn't work out. My apologies to Gigi if I didn't sufficiently acknowledge her efforts the first time around, but it is a back-handed compliment of the highest order. Rescue volunteers like her make my job so much easier that I can almost forget how much work they are actually doing!

Judy Agnew, the Florida Club's rescue chair, got a call about a shelter Kerry in February. This 5 year old male **import** had been adopted out by the shelter and then returned two weeks later when he allegedly bit the new owner. Since the exact details were not clear and shelter workers saw only a friendly and outgoing dog, they wanted someone to give him another chance. After taking the dog into her own home for evaluation, Judy was able to track down somebody familiar with his early history, and discovered that he had bitten other people and been through at least two previous homes because of ongoing issues with dominance-related aggression and resource guarding before being relinquished to the shelter. The shelter had not been told any of this. A dog like this is not safe to adopt to anyone, and he was humanely euthanized. Thank you, Judy, for handling an extremely difficult situation both professionally and with compassion.

Several members of the Ohio Club were contacted in February about *Murphy*, an approximately 3 year old

# Ch. Warlord's Scarf Mackenzie, HCT-s, HT-s First AKC Herding Title for Kerry Blues!

Herding Sheep at 2500 feet plus, and Kenzie wasn't even out of breath. Although she was outnumbered by Border Collies, and traditional herding breeds at the Border Collie Club of Greater Los Angeles AKC Herding Trial and Test held March 8 and 9 in the high desert elevations above Lancaster, California, it did not bother her a bit to be the only terrier. Ch. Warlord's Scarf Mackenzie, HCT, and now with AKC herding titled, "HT" herded her way to the first AKC herding title for Kerry Blues, since the breed was approved to receive AKC herding tests and titles in January 2007.

"Kenzie" was provided three heavy Dorsett sheep for her herding test by the host club on Saturday, at the very end of a blue sky, 59 degreed, very windy day. Being in the "Test Class" and going in reverse order, she had to wait her turn for most of the day, watching approximately 50 advanced herding dogs, mostly Border Collies, herd their sheep. After all, it was their herding club in northern Los Angeles County and she was a guest, attending their local AKC herding trial.

The heavier Dorsett sheep are preferred for testing, particularly with the high winds that were occurring on Saturday. Lighter sheep are often more affected by winds. Kenzie patiently waited her turn and was unaffected by the winds and the 50 dogs trialing ahead of her, mostly advanced Border Collies, Australian Shepherds and a few Tervurens who were all so much more advanced at herding, enjoying the larger herds of sheep, that she <u>really</u> prefers.

Hours later, Kenzie's number was called and she remembered everything she had learned, even though she had not seen sheep for a while and had not been able to herd that day, until her number was called. Of course, she always had her Kerry Blue herding instinct. THAT she will never forget and will never lose.

Thank you to the AKC for the Kerry's opportunity to herd as they have been herding for hundreds of years and to the USKBTC, Bob Nazak, Tom Rogers, Carl Ashby and Charlie Redmon for making it all happen with the AKC that Fall in 2006; thank you Diana and Will Harper for their creative genius in creating the Herding Video in 2006; and AKC Herding Judge and my trainer and handler Judy Vanderford for being our herding supporter and a believer in Kerry Blues. It was a joy, a thrill I will never forget, and one I want to share with others and their Kerries.

# SOME FURTHER THOUGHTS ON TRAINING: THE WAIT AND THE CRATE by Margo Steinman

Basic training is a tool which makes it easier to live with your Kerry. It can involve formal obedience training, or include only training for situations around the home or when traveling.

The "wait" command is basic, and can be used in many different ways: not dashing through an open door or gate, waiting to eat after food has been put down, not jumping off a grooming table, out of a crate, or out of a car. All of these situations also involve establishing dominance, and can also insure your Kerry's safety. Wait implies imminent motion after a release command; I use "OK", but other commands could also be used.

"Wait" should not be confused or used interchangeably with "stay". At home, I use stay when the dog is expected to remain in position for a longer period of time than wait, and rather than giving a release command, I always return to a heel position by the dog, and then release it. In the obedience ring, stay is used before leaving the dog for the long sit and long down exercises, as well as before a recall, retrieve, or jump.

Of course there are no rules as to which commands you can use, as long as the dog understands what you want it to do, and you are consistent.

To use the wait command the dog should first have been trained to sit and down on command, and should be wearing a collar. For training the dog not to dash through an open door, for example, tell the dog to sit (or down), praise it, give the wait command, and while holding the collar, open the door. As long as the dog remains in position, praise it, and after a minute or longer, give the release command, let go of the collar, and allow the dog to go out the door. This also works to train the dog to allow you to go out the door first, which is important in establishing dominance over the dog. I also use this technique in feeding; my dogs wait until the release command to go to their food dishes and eat.

In crate training, the dog must be trained to go into a crate on command. **This is never done to punish the dog**. I begin by showing the dog a treat, which I then put in the crate, and tell the dog "crate". When the dog goes in the crate and eats the food, I praise it, give it another piece and then release it. I also train my dogs to eat in their crates, which is useful when traveling, and keeping food possessive dogs separated while they eat.

Once the dog has learned to go in the crate on command, teach it to wait for a release command when you open the door of the crate. Again, have a collar on the dog. Open the crate's door, take the dog by the collar and attach a lead while telling it to wait. You can also leave a short lead or tab attached to the collar. When you give the release command, you will have a lead on the dog, which makes it easier to control, especially at dog shows or when the dog is crated in a car in a parking lot. When you first begin this training, you may have to hold one hand in front of the dog's face to prevent it from barging out of the

crate, while you reach for the collar and attach the lead. The dog should not leave the crate until it is released from the wait.

"Wait" and "crate" make it a lot easier to live with your Kerry. The wait command can save your dog's life, help you establish dominance over the dog, and in combination with the crate command, prevent dog fights over food or toys. And the dog is much safer in a car when crated in a tied down crate, as it will not go flying through the car if you have to stop suddenly, or jump in your lap to get to a dog it sees outside the car. If you feel safer with the dog beside you, use a harness attached to the seat or seat belt, and inactivate the passenger air bags.

male Kerry in a shelter. He had been adopted out once and returned when he didn't get along with the owner's cat and other dog. Because Murphy was also barking and lunging at other dogs at the shelter, shelter workers were concerned that he may not be adoptable, and another rescue group wanted someone familiar with the breed to go to the shelter and make a life or death decision about him there. Thank you Ellen Hines and Airedale breeder Sue Stafford, who along with AKC judge Dennis Kniola confirmed that this "poodle/terrier cross" was indeed a purebred Kerry Blue Terrier, and got him out of the shelter so he could be properly evaluated in a home setting. Dennis boarded Murphy for three days until Gretchen Quinn was able to pick him up for fostering. Happily, Murphy did turn out to be a typical loving-yetexuberant male Kerry, and he is promised to an experienced family with no other pets as I am writing this. Connie Myers, Barbara Beuter, Lynn Duckett, Sue Gilmore, Charlie and Sandi Redmon, and Janis Whittier also deserve a nod for their help in Murphy's rescue and placement.

Finally, I want to thank all the other USKBTC and Chapter Club members who have worked in recent months to place Kerries both individually and through their Chapter Clubs, and have kept many other Kerries out of Rescue by providing support and advice to their owners. 

# Kerries Keepin' Sheep in Carolina! Sheep are Impressed with Kerry Blue Terriers at an Instinct Testing in North Carolina

Getting Started in Herding: This issue includes the journey of a young Kerry who is working toward her AKC herding title with her owners, trainers and handlers in North Carolina.

Well, it may be going a bit far, speaking for the sheep, but when long time sheep dog trainer and cattle dog trainer, Vickie Hughes, owner of Possum Hollow Farms, Rutherfordton, North Carolina is impressed, you can be sure the sheep are impressed. On February 16, Possum Hollow Farms

(www.possumhollowfarms.com) held a herding instinct testing with Ch. Liberty's Princess Diana, "Layla", 2½ years old, demonstrating to four other Kerries and four Eskies, exactly how sheep herding was to be done. Layla has been training at Possum Hollow Farms for her AKC HT title for the past 6 months, twice a week with trainer and owner of Possum Hollow Farms, Vickie Hughes and her assistant, experienced shepherd and animal trainer, Lauren Hohensee who trains and shows her own Border Collies and Cattle Dogs. Layla had passed her herding instinct testing last fall and as we go to press on March 10, Layla is preparing to test for her AKC herding title on March 23 in Atlanta. We are looking to celebrate a herding title soon after!

Connie and Allen Comeaux own Layla and are from Ashville, North Carolina. Allen, retired from the phone company, is a missionary, and now is involved in two types of 'shepherding,' one literal, and one figurative. Layla is sired by by Ch. Bluebeard's the Answer, and out of Liberty's Murphy Blue, and was bred by Paul Coulaz and Arlene Lauren. Last August, Layla, who finished her AKC conformation championship at about two years old, also obtained her AKC Canine Good Citizen certificate, which has contributed to her herding trainability. Although obedience commands are not necessary for instinct testing, the ability to respond to the handler's commands is an advantage in training for herding titles. Layla's trainers plan to continue to work with her beyond her AKC herding test titles of HT and PT and will continue to train Layla for AKC herding trial titles.

The Instinct Test Day drew attendance from four other Kerries who successfully herded sheep that brisk February day, following Layla's exceptional demonstrations. Also impressing sheep that day were Ch. Topgun Maverick to the Danger Zone, "Maverick" owned by Barbara and Roger Price, who is a son of Mick, and "Smoky", who is one point from earning his AKC championship. Maverick and Smokey took turns burning up the

sheep trails and could not get enough of their herding experience. It was a toss-up as to which boy was going to take home the mythical herding trophy that day! Tracy and Randy Percell own "Smoky", Topgun Great Balls of Fire.

Barbara and Roger Price and Mrs. Evelyn Smith own Ch. Harvey's Lady O'Grady of Topgun "Lady". Mrs. Smith came all the way to the herding test from Indiana to see her Kerry, "Lady" pass her herding instinct test. Mrs. Smith is in her 90's and won Westminster with her Kerry in the 70's. She stated that to see the breed succeed in herding was very gratifying to her. Being true to her name, "Lady" passed her herding test with grace, like a "lady" and left the rough and tumble style of herding to the boys.

Katahdin sheep, whose wool is shed, were used in the testing, in case a dog is tempted to do a little 'wool tasting' when they first see the sheep. There is no proof, because no one is 'talking' but there may be some wool in some of the boys' beards! We will never know for sure! Seriously, though, 'wool tasting' is common and usually does not last, once the dog learns he or she can control the livestock without it. That is the benefit of the wool shedding sheep and why they are used in herding.

In addition, passing his instinct testing was Ch. Topgun Reagan for Freedom. Debi and Jim Hayes own "Reagan". Reagan has had some prior herding experience and is known for his agility talents. He and Jim have an article on the USKBTC performance/herding website.

Vickie Hughes had not worked with Kerries before and was very impressed with the breed and their interest in herding sheep and goats. Her breeds were primarily Border Collies and Australian Cattle Dogs, although she had worked with many other breeds, she had not seen Kerries herd, She is now a believer in the breed's ability to herd. Vickie also works herding cattle from a horse. "Layla loves herding!" says her owner, Allen. "We have to be creative, and keep changing the routine for her. She becomes bored when she masters something and looks at us, as if to say, 'okay, what's next?"" (Maybe cattle from horseback?) Vickie and her assistant Lauren and their staff provide herding clinics, demonstrations and seminars in South Carolina, Tennessee and Georgia as well as North Carolina.

# Hints from the Herders:

# Teaching a Recall and a Lie Down;

Teaching a lie down command is useful for herding, but dogs generally forget all they know, once they see the livestock; to recall your dog use the word "here" rather than "come"—later,

"Come bye" will mean the dog will go around the livestock in a clockwise fashion—the words "go bye" are also used in some areas; the command "Here" –is therefore less confusing for the dog.

The command "Away" (pronounced: "A wee") tells the dog to go counter clockwise around the stock. Layla demonstrated both directions to the class that day as well as the lie down and recall commands. To demonstrate these herding commands at 2 1/2 years and only after 6 months of training is exceptional.

# Teach your dog to ignore excitement:

Teach your dog to lie quietly at your feet when there is a lot of excitement going on; dogs that bark a lot at herding trials are not welcomed, and are often asked to leave.

# Livestock and Camps

Possum Hollow offers opportunities to train in herding with cattle, sheep and ducks, supporting all three types of livestock for AKC titles offered, beginning last January 2007, for Kerries. Sheep herding camps are also offered at Possum Hollow, where an owner can camp with his/her dog for three days with a more intense focus on herding. Facilities that offer camp opportunities give the handler, an opportunity to bond with one's dog in the herding environment, and for the dog to become more familiar with sheep on a daily basis, bringing out the 'working' dog in his or her nature.

Finding a local training facility if often difficult. We recommend that you contact local stock dog clubs or herding clubs through the internet and ask if they can assist or refer you to a facility in your area who will work with you and your dog. It is not unusual to drive an hour or more to find a facility for training.

So get some friends together and have an instinct testing at your local herding facility. With our breed's interest, you are sure to have a great time and you will find your dogs begging you to take them back for more sheep!

# Notes from Health and Genetics...

# Congenital vs. Hereditary

A hereditary trait is genetically transmitted from parent to offspring. It is derived from one's ancestors. The most common hereditary diseases in dogs include the following:

Allergies Hip dysplasia Cardiac problems Epilepsy Cardiomyopathy **Hpothyroidism** Elbow dysplasia Cataracts

Progressive retina atrophy (PRA) von Willebrand's disease

Many genetic disorders are visible, but mutations may also cause disease at the biochemical level. Diagnosing becomes more difficult and such defects may cause death within the first few days. These puppies are called "faders". Metabolic screening is recommended for neonates displaying symptoms compatible with an inborn error of metabolism. Testing may be performed at the University of Pennsylvania Metabolic Screening Laboratory. For detailed information go to www.vet.penn.edu/ penngen.

Congenital means existing at or dating from birth. A congenital trait is acquired during fetal development and is NOT through heredity. The rate of occurrence of congenital defects in neonatal puppies has been reported about 7%.

The developing fetus is most susceptible to teratogenic insult during the first three weeks of pregnancy. Potential teratogens include environmental pollutants, plants, vitamins, minerals, hormones and certain drugs such as antibiotics, anticonvulsants, antineoplastics or antiinflammatories. A variety of infectious organisms may induce congenital abnormalities.

Developmental anomalies may also be caused by other factors such as ionizing radiation, temperature extremes, hypoxia, maternal metabolic disease and trauma. Anomalies affecting the central nervous, cardiovascular, or respiratory systems may be incompatible with life resulting in resorption, stillbirth, or death shortly after birth.

Congenital heart disease is recognized quite frequently. Common defects include cardiac endocardial fibroelastosis, septal defects, Tetrology of Fallot, patent ductus arteriosus, valvular dysplasias, persistent right aortic arch and valvular stenosis.

Common defects affecting the digestive system include cleft palate and cleft lip, atresia ani, patent ductus venosus, megaesophagus, and segmented agenesis of the GI tract. Some cleft palates require immediate care because of their effect on suckling. Affected pups may die if left untreated.

The musculoskeletal system may be affected by bra-

chury, craniofacial abnormalities, diaphragmatic hernia, kinked tail, polydactylism, umbilical and inguinal hernias and vertebral malformations.

Hydrocephlus is a common disorder of the forebrain affecting the nervous system and may be evidenced by seizures or other behavioral disorders. Cerebellar hypoplasia, neural tube defects and spina bifida are also commonly diagnosed congenital neurological defects.

Opthalmic and otic defects should be screened for at the initial pediatric exam. Common defects include cataracts. corneal dystrophy, deafness, dermoids, ectopic cilia, entropion and ectropian, and pinnal malformations.

Reproductive disorders which could be evident at the pediatric exam include cryptorchidism, intersex conditions, hypospadius, persistent penile frenulum and vulvovaginal defects. {Many years ago when I worked for a pofessional handler and breeder of Miniature Schnauzers, I witnessed a litter of puppies that we could not determine if they were male or female. I was told by the kennel manager that the pups were being sold as pet females. It would have been interesting to see which sex organs those dogs had internally.}

Renal agenesis, persistent urachus and ectopic ureters affecting the renal system may be seen in young puppies.

Dermatological defects such as epitheliogenesis imperfecta, alopecia universalis, albinism, dermoid sinus and excessive skin folds (Shar pei, bulldog) are sometimes encountered.

A problem is more likely to be a hereditary defect if it has been shown to be genetically transmitted in another breed or species. Genetic disease tends to occur in more than one litter produced by a dam or sire. Inbreeding will increase the frequency of a genetic defect. Determining whether a defect is hereditary is not always possible. It is distressing to breeders when a genetic disorder is confirmed.

# Kerries are SRO at the Westminster Kennel Club Dog Show, as Ch. Perrisblu Paris "Paris" takes on New York with Best of Breed!

One would never know that Kerries were not one of the more popular breeds in the AKC, as the Westminster Kennel Club gathered at Ring 6 at 11 am February 11<sup>th</sup>, to welcome the eight champion Kerry Blue Terriers who travelled to New York City from all corners of the states, in 15 degree weather, snow threatening, to represent our breed. The crowd stood five deep, straining to see, whispering to each other about how beautiful the dogs were. Impeccably groomed, each was a magnificent sight, as they entered the ring, and the crowd gasped. There was electricity in the air. One could feel the excitement even though the crowd was not consisting of all 'Kerry' people. The crowd appreciated our breed, and it made our Kerry fancy proud of our small, but very beautiful and elegant representation at this historic event.

Monday, the New York Times had published an article about Ch. Torum Scarf Michael, who had won Westminster's Best in Show in 2003. The article featured "Mick" and his progeny. The article stated that one of his daughters, Ch. Sethfield Gazon Mickbeth, owned and bred by Carol Greenwald, was among the entries. 

The Committee will be involved in producing Kerry Blue Terrier promotional material such as display banners and brochures. These will be available to members through the USKBTC for their individual use.







- 2. Thirty (30) days after publication in BLUEPRINTSSM, your application and any members comments will be submitted to the Board of Governors for
- 3. You will be promply notified, in writing, of the Board's action.
- 4. You will be provided with a copy of the approved Constitution and Bylaws.

This Membership process can take up to six (6) months or more, due to the publication of BLUEPRINTSSM three times per year, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership, your application fee will be refunded.

# THE UNITED STATES KERRY BLUE TERRIER CLUB **CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United Stated Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

# I. RESPONSIBILITIES AS A MEMBER

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

• Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

## II. RESPONSIBILITIES AS A BREEDER

#### A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names, and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration spplications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

# III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

#### IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
