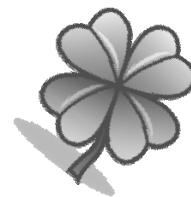

Futurity Changes!

Dear USKBTC Member:

As many of you know the Haymarket Futurity, held in conjunction with the National Specialty every October, has been an important part of our Club's activities for over 20 years. Over that period there has been virtually no change to this event although exhibition patterns have changed significantly. These changing patterns have resulted in a steady decline in entries over the past several years.

The USKBTC Board of Governors has been considering several changes to add new excitement to the Futurity and to make it more attractive to enter your young dogs. The first change, which is being implemented at this year's Futurity, is to add four additional classes. These classes will be open to dogs and bitches 18- 24 months and 24- 30 months. These classes will be judged in the same manner as the other Futurity classes are judged. The winners of these 4 classes will compete for Best Senior Dog in Futurity. These classes will not compete against the younger dogs. The result will be a Best Jr Dog in Futurity and Best Sr Dog in Futurity and Best of Opposite Sex for both Jr and Sr dogs. Judging for the 4 new classes will be at the end of the traditional judging in order to allow dogs to return from Devon.

For this year ONLY....a Kerry which falls in the age range of the two new classes, whether they were originally nominated for the Futurity or not, will be eligible to compete provided they meet the other entry requirements. In 2011 and beyond, in order for a Kerry to compete in these new classes, it must have been from a litter that was nominated for the 2010 Futurity and for which appropriate payments have been made. More details on this will be available over the next several weeks regarding entry procedures.

We are excited about these changes and hope you will consider participating in the 2010 Haymarket Futurity. Our goal is to make the Futurity a highlight of the Kerry year and your participation is key to its success. If you have any questions or concerns please call me at the number below.

Proper Presentation of a Kerry Blue Terrier's Coat

To: Kerry Blue Terrier Breeders, Owners, and Handlers

From: The United States Terrier Club Board of Governors

We have recently noticed a disturbing trend in the breed ring. A small but growing number of handlers, particularly professional handlers, are exhibiting Kerry Blue Terriers with coats that are blown out straight, with all signs of wave removed, and then trimmed extremely short (1/2" or less) on the body. While grooming and presentation in all breeds can and does change over time, the Board of the USKBTC considers this current fad unacceptable, as it makes it impossible to properly assess coat texture as called for in our Standard. Specifically, the Standard states, "Correct coat is important. It is to be soft, dense and wavy. A harsh, wire or bristle coat should be severely penalized. In show trim the body should be well covered but tidy, with the head (except for the whiskers) and the ears and cheeks clear."

The Kerry Blue Terrier Illustrated Standard further elaborates on coat, describing it as: "Silky, soft, dense, with waves. The combination of these singularities of coat are unique to the Kerry Blue Terrier. The single coat should always be soft, plentiful, dense and wavy. Marcel waves should resemble finger waves, not curls or kinks. The texture is silky, not wooly or harsh. A fuzzy, cotton coat is equally as improper as a harsh coat...In show trim the body should be well covered but tidy, (coat should be [long enough to be] wavy and mold to the body like a well-fitting garment). On the head, (except for the whiskers), the throat, ears, and cheeks are clipped. The rump and back of tail are trimmed close or clipped. A Kerry Blue coat shaped into a "poodle pack" with every hair standing straight up, (stand away coat), showing no waves, is uncharacteristic and is a major fault." (p. 15)

Grooming the body coat correctly, leaving the appropriate length to develop a wave, not only allows a judge to more accurately evaluate the coat's true color and texture, but makes any foreign substances that may be used to enhance or disguise these very important breed characteristics easier to detect.

In the past, when AKC breed standards were based on a point system, coat and color in Kerry Blue Terriers merited a full 25 of the 100 available points. In our current standard, this is emphasized in no less than three different places: General Appearance ("correct coat and color are important"); Coat ("correct coat is important"); and Color ("color is important").

We ask that Kerry owners adhere to our breed standard and leave sufficient coat on their dogs when they are being shown, refrain from blowing out or "packing" body coat, and not tolerate incorrect presentation by the handlers they employ to show their dogs.

New AKC Grand Champion Award!

Who is Eligible for Grand Champion competition?

The following categories of dogs are entered in this competition:

1. Dogs that are Champions of Record competing in Best of Breed or Best of Variety class.
 2. Dogs transferred to Best of Breed/Variety which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. (*The showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of show where a dog completed the requirements for a championship according to the owners' records.*)
 3. Champions that win Non-Regular Classes and become eligible for Best of Breed competition. (*Altered or spayed CH veteran class winners at independent specialties are eligible.*)
- Winners Dog and Winners Bitch are not eligible for Grand Champion competition.

At the judge's discretion, Grand Championship points may be awarded to:

1. Best of Breed or Variety
2. Best of Opposite
3. Select Dog
Select Bitch

Grand Champion competition will not continue beyond Best of Breed competition and in breeds that are divided into varieties, Grand Champion Competition will not continue beyond Best of Variety competition.

What are the requirements to earn the Grand Champion Title?

1. 25 Grand Champion points.
2. A minimum of 9 points won at 3 shows with ratings of 3 or more points (Major wins) under three different judges, and one or more of the balance of points won under a 4th judge.

At least one Champion of Record was defeated at three of these shows.

How are Grand Champion points computed?

1. Grand Champion points are only to be awarded to dogs the judge considers deserving.
2. Grand Champions points awarded to the Best of Breed/Variety shall count all dogs of both sexes competing in the regular classes and in Best of Breed/Variety competition.
3. Grand Champion points awarded to Best of Opposite Sex shall count all dogs of their sex competing in the regular classes and in Best of Breed/Variety competition.
4. Grand Champion points awarded to Select Dog/Bitch shall count all dogs of their sex defeated in the Best of Breed/Variety competition as well as the dogs of their sex in the regular classes. (i.e. one less than the total entry in that sex)

The entry of non-regular classes are not counted for computation of Grand Champion points to be awarded.

Judging Procedure

Choose BOB, BOW and BOS

If quality warrants, choose a Select Dog (SD) and Select Bitch (SB) from the remaining Champions in the BOB ring (Do not consider BOW, WD or WB)

Annotate the judge's book certification as to the eligibility and quality of the Grand Champion points being awarded or withheld.

Award BOB, BOW, SD and SB ribbons if determined to be of eligible and deserving of the Grand Champion title. See: http://www.akc.org/pdfs/judges_sheet_conformation.pdf for example of the revised judge's book form.

Administration

1. On May 12, 2010 Grand Champion competition will be included in all shows offering BOB or BOV com-

petition.

2. Premium lists – Other than prize listings, there is no requirement to address Grand Champion competition in the premium list since it is included in all shows that offer BOB or BOV. However, there is no restriction should superintendents and secretaries want to bring attention to the new competition.

3. Judging Schedule – No additional information is required.

4. Ribbons – BOB and BOS do not require an additional ribbon. Light blue & white ribbons for SD & SB. Flat ribbons or rosettes are equally acceptable. "Select" is acceptable wording however "Grand Champion Select" is acceptable and more descriptive.

Ring Markers – Just as with BOB, BOW and BOS, there is no AKC requirement to have SD and SB placement markers. These markers are provided as a service by the club or superintendent.

FIRST 10 AKC GRAND CHAMPIONS IN EACH BREED TO RECEIVE SPECIAL MEDALLION

- First-Ever AKC Grand Champion "Stoli" Recognized at Oklahoma Dog Show -

New York, NY - In recognition of the newest American Kennel Club® Grand Champion conformation title, a special blue enamel AKC Medallion will be sent to the owners of the first 10 Grand Champion title holders in each AKC-recognized breed to mark this historic achievement.

To kick off the Grand Champion medallion program Director of AKC Event Management Michael Canalizo, joined by AKC Board Member Lee Arnold and Executive Field Representative Sue Vroom, made a special presentation to the first-ever Grand Champion, GCH Monterra's Best Bet, MH, a 4-year-old Weimaraner affectionately known as "Stoli" bred and owned by Elizabeth Krupinski and co-owned by Timothy Bintner of Elizabeth, Colorado and handled by Tad Walden. Stoli received a special gold AKC Medallion at the Oklahoma City Kennel Club show on July 2, 2010.

"We are pleased to present the first 10 Grand Champions in each breed with this special AKC Medallion," said Robin Stansell, AKC Vice President of Event Operations. "Completing the Grand Champion title is quite a feat and we are excited to recognize the dogs and their owners for all that they have accomplished."

AKC will send a congratulatory letter and one medallion to the owners following verification of the title. Owners and co-owners may order extra medallions by written request. For more information, contact Bobby Birdsong, Director of AKC Event Operations at bwb@akc.org.

All dogs that complete their Grand Championship will receive an invitation to the AKC/Eukanuba National Championship in Long Beach, California to be held on Dec. 4

Believing in the Goodness of People and the Goodness of Dogs

If you met Bob Nazak, you were considered a friend.

If you did not know Bob personally, but you own a dog you will benefit from Bob Nazak's voice in the canine world for many years to come. Bob worked tirelessly for you and your dog, even though he did not know you.

On Monday morning, June 21, 2010 we lost a special friend, suddenly and unexpectedly. His wife Martha, his three children, their families and his friends did not have a chance to say goodbye. It has been said that we do not get that choice in life. As one of his many friends, this tribute is offered to honor Bob and the many ways he gave to our lives through our dogs. Perhaps knowing how he believed in the goodness of people and the goodness of dogs will help to carry on the work he believed in and supported. I think Bob would like that.

Family, Friends, Community-Their Dogs

Bob loved his family and his friends and never lost focus on his priorities. All three included dogs, of course. Dogs, as they were wont to do, soon found their way into his heart with his wonderful wife and best friend, Martha, early in their lives. Martha had the grooming and handling priorities and Bob was in charge of the operations and management division. Bob and Martha were a great team. Being around them both was truly a pleasure for all who knew them. Bob celebrated life, loved dogs and loved people. His enthusiasm was contagious.

Service: AKC, ODKC, USKBTC, Canine Human Bond

Bob believed in the canine human bond and worked tirelessly at the AKC level, serving as an AKC delegate for the past 7 years. At the regional level he worked as a board member of all-breed Old Dominion Kennel Club and at breed level, served as a board member of the USKBTC to support projects that expanded the canine-human relationship and gave back to our society. He loved the canine's ability to contribute to those in need, particularly children having difficulty reading. Bob was instrumental in developing the USKBTC Charitable Funds "Kerry It Forward Award", recognizing Kerry Blue Terriers who have contributed to the canine human bond, beginning this year, 2010. Bob often said that we have only begun to discover the canine's true abilities to contribute to our lives and to our well being through the various therapy dog programs.

Bob grew up in northeastern Pennsylvania and always loved dogs. Dogs were always present in Bob's life, beginning with Trix, a spitz mix and then an English Springer Spaniel called Folly. Nutmeg an Airedale was their introduction to terriers in 1970, leading to Brigid, a Kerry Blue Terrier in 1984. The Old Dominion Kennel Club and the USKBTC membership soon followed, along with numerous leadership positions. Bob served on the board of the ODKC since his second year of membership and was active in show operations, serving as Treasurer, Vice President and President and for the past 7 years served as the kennel club's AKC Delegate. Bob and Martha both believed in mentoring new members/owners and would often volunteer to assist new owners in grooming, handling and ear setting.

Bob and Martha retired the USKBTC National Specialty Trophy in 2004 with Ch. Fralin's Clíodhna of WhimSea "Nixie" (Ch Torum's Scarf Michael x Ch Fralin's Bit Of A Risk).

Am and Can Ch Tontine's American Hero "Ollie" (1987-2001) won Montgomery County Best of Breed in 1990 and 1992. Ch. Bluebeard's All American Girl, CGC "Amy" (1990-2002) earned her AKC Canine Good Citizen Award. The dogs often accompanied Bob and Martha on their travels. The past few years found them in their motorhome traveling with "Nixie" for 4-6 weeks in the spring, exploring the southeastern and southwestern US, making friends wherever they would go. One fascinating story Bob wrote for Blueprints was a trip they took with "Amy" years ago to a Gettysburg civil war battlefield that involved a particularly devastating battle. Amy steadfastly refused to go near the area, whining and protesting loudly...a behavior very much unlike Amy. The monument was to the Irish Brigade and their Irish Wolfhounds who had died in battle there. What Amy did not know was that one of Martha's ancestors had also fought (was wounded and survived) in that battle. Dogs have insights that we do not understand, Bob would often say.

As an AKC Delegate, he was also active in opposing breed specific legislation. That legislation is still pending. Bob was instrumental in obtaining approval for Kerry Blues to receive AKC Herding titles in 2006, serving on the committee and lobbying extensively. In 2008 our USKBTC was asked and agreed to support Soft Coated Wheaten Terriers to obtain their herding certification. Bob actively supported and lobbied at the AKC level for the Wheaten AKC herding petition and saw its passage in May 2010. Kerry Blues and Wheatens are the only terriers approved for AKC herding. Bob believed participating in activities with your dog contributes to the canine human bond.

Service: US Naval Academy and Dogs

Bob Nazak was a 1958 graduate of the United States Naval Academy and often wore his Navy cap to dog shows. He told me he met many people that way. He completed post-graduate studies in science, engineering and project management at the US Navy Graduate School, Monterey, CA. He retired from the Navy after 23 years and served another 23 as a consulting engineer in Washington, D.C. In 2004 he retired with Martha and "Nixie" to Lake Anna, VA and bought a boat. Bob had a great sense of humor...Christmas cards had Nixie with her life vest on at the "helm of the ship." Bob always gave her the credit for keeping the Lake Anna waters safe from hostile invaders!

We would often have mini Navy Class of 1958 "reunions" at Eukanuba in Tampa and in Long Beach with Bob and Martha and fellow classmates Dwight Hutchinson, and my husband Bob, who were also in the class of 1958, along with Dwight's wife Lydia. We would celebrate the Navy and our favorite group, the Terriers! Bob stayed active with his college alumni as many do, but again "dogs soon became an active part." Bob was actively working on legislation to assist the military and their families to be able keep canines in base housing. Bob believed that those serving our country needed their dogs even more. In Bob's honor, Carl Ashby will carry this on.

Bob worked for the Kerry Blue; he worked for other breeds; but he also worked for the dog and the owner he would never meet.

Bob Nazak believed in the goodness of people and the goodness of dogs. He worked to bring them together for the benefit of both.

Although we did not get to say goodbye, we will do our best to carry it forward.

A Word from Charitable Funds...

As many of you know the US Kerry Blue Charitable Fund was established in 2002. Its purpose was to serve the Kerry Blue Terrier in four important areas:

- 1) **Rescue Fund** – this fund supports grants used to provide Kerry Blue Terrier rescue services.

 3. You will be promptly notified, in writing, of the Board's action.
 4. You will be provided with a copy of the approved Constitution and Bylaws.
- This Membership process can take up to six (6) months or more, due to the Quarterly publication of BLUEPRINTS, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership; your application fee will be refunded.

**THE UNITED STATES KERRY BLUE TERRIER CLUB
CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

I. RESPONSIBILITIES AS A MEMBER

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
