The revised guidelines covering the Judge Selection Process are published in this issue. Please read and retain this information for future reference. Thank you Gigi Lorentz-Reiling, chair, Carl Ashby and Dick Schaefer for your hard work and dedication to this project. USKBTC Members WILL SELECT the Judges, not the committee. The new committee, consisting of Dick Schaefer, Gigi Reiling, Nick Fletcher and Margo Steinman will manage the process.

The proposed amendments to the clubs constitution and by-laws are acceptable to the AKC. These will be submitted to the members for a vote. These are NOT sweeping revisions, but rather clarifications and modernization made to conform with AKC guidelines. One of the changes splits the responsibilities of secretary into both a recording and corresponding secretary. Thank you Bill Lynch for chairing this committee and Carl Ashby, Martha Nazak and Gretchen Quinn for serving.

I want to thank the outgoing governors, Nick Fletcher, Carol Kearney, Bryan Kincaid and Martha Nazak for their dedication to the Kerry Blue Terrier and the USKBTC. We have 31 active committees plus 11 committees dealing with events and competition, all of which involve some level of board participation.

In addition to Martha as chair, the nominating committee consisted of Bonnie Whelehan and Dick Schaefer with Linda Olsen and Terry Worful as alternates. Martha and Carol are term limited. Professional demands on Bryan and Nick are such that they are, at this time, unable to serve another term. The slate recommended by the nominating committee consists of Lisa Frankland, Bill Kearney, Dr. Jann Lane, Tom Rogers and Carol Wert. Bios have been mailed to all members. This slate was developed to reflect the geographic location and interest level of members. In addition, Dr. Scott Kellogg submitted a petition and acceptance letter declaring his candidacy. We now have six experienced and qualified members of the USKBTC running for the board."

The USKBTC has pulled its application for the KBT to participate in earth-dog events after being informed by the AKC that dogs in the Master Test must negotiate obstacles, turns and obstructions in a tunnel that constricts to approximately 6 inches. After a discussion with USKBTC members and other larger terrier club members interested in earth dog/strong dog events, a determination will be made on how to proceed. James R. Tebbetts has been working to develop an event for the larger terriers. Information on such a proposed event written by Jim is printed in this edition of Blueprints on page 12. In the meantime, we are proceeding with AKC approval for Herding!

Lynn Duckett has resigned as rescue chair. Lynn, assisted by dedicated members, devoted considerable time and effort to rescue for many years. Thanks to Lynn and all who are participating in rescue. A committee is in the process of reviewing how the USKBTC rescue program functions with a view towards broader chapter club participation. The objective being the best possible program for the KBT. Few KBT's bred by USKBTC members require rescue; most of those ending up in rescue originate in puppy mills.

Dr. Scott Kellogg, Health & Genetics chair, has secured a commitment from Dr. Giger to address the Factor XI Mutation at 5:30p.m. before our annual meeting and dinner on Friday, October 6.

Fred Fishell's Kerrytoons book "The World According to Mike" is hot off the presses and will be available on the web site, from chapter clubs and at Montgomery. Thank you Fred Fishell and Carol Kearney for making this happen. The proceeds will go exclusively to support USKBTC Charitable Funds efforts.

Many of us attend Montgomery in RV's. With the Futurity being held at the Hatboro grounds in 2006, eliminating the need to move R.V.'s, concerns were expressed about transportation to Fishers. We are arranging for both security and transportation from Hatboro to the annual meeting and dinner.

I had the opportunity to attend the KBTC of S.C. Specialty held in conjunction with the Great Western Terrier Association show at the new El Dorado Regional Park show site in Long Beach, California. This large park is convenient to regional airports and has ample parking for cars and R.V.'s. The members of the KBTC of S.C. worked hard and had a most successful show! They are ready for next years USKBTC Traveling Specialty. Plan to attend, you will have a great time.

NEED TO PROTECT THE RIGHT TO OWN AND BREED, Never Greater Message from Walter Bebaut, AKC Caping Logislation Director

The introduction of crop and dock ban bills, breed-specific legislation, and mandatory spay/neuter ordinances is rampant across the United States. From Los Angeles County, CA, and Albuquerque, NM, to San Antonio, TX, and Louisville, KY, local governments are embracing mandatory spay and neuter ordinances as a panacea to deal with perceived pet overpopulation issues. So far in 2006 we have seen the consideration of an ear-cropping-ban bill in Vermont and the introduction of a crop-and-dock-ban bill in New York state. Breed-specific legislation, banning the ownership and/or breeding of certain breeds, plagues dog owners in scores of communities. The need for a resolute dog fancy committed to protecting the right to own and breed dogs has never been greater.

Our own complacency constitutes a serious threat to responsible dog ownership. It is all too easy for a dog owner involved in breeds not cropped or docked to have the view that crop-and-dock-ban bills do not affect them or their breeding programs. The same attitude can dismiss the relevance of breed-specific legislation if your beloved breed or breeds are not included in a proposed breedspecific ban in your community. Mandatory spay and neu-



ter ordinances may provide exemptions, usually for "competition/performance/show" dogs, so again the outlook can be that "my dog is in a 'special class,' and my right to breed is exempted and protected under mandatory spay/neuter ordinances."

But exemption from mandatory spay and neuter requirements comes at a high price. Albuquerque, NM, requires an annual \$150 intact animal permit and a \$150 litter permit, while Los Angeles County, CA, features a \$60 intact animal license and a \$175 litter permit if you choose to breed a bitch. But the greatest cost to dog fanciers is not monetary. Instead mandatory spay/neuter and crop/dock bans and breed-specific legislation singly and collectively threaten the rights of dog ownership.

The menace of repressive dog legislation is not a complex issue. Instead it reduces to a simple question: Who should make the decisions regarding dog ownership and breeding -- the responsible dog owner or the government? If your answer is that owners and breeders should make those decisions, then every piece of negative canine legislation introduced becomes an issue requiring active opposition by everyone in the purebred dog community. The common bond between all dog fanciers is our love of the purebred dog. Dog fanciers have shared interests, and we also have a shared responsibility to protect the right to own and breed dogs.

Health and Genetics Updates

PNA Research Report

by Gigi Lorentz-Reiling

I just talked to Liz Hansen, who is with the Animal Molecular Genetics Laboratory at the University of Missouri, regarding concerns about the research status and the recent AKC Canine Health Foundation communication. The following is a summary of our discussion.

Question 1 to Liz: Is the vet school aware of documentation distributed by the AKC CHF that refers to PNA/MSD as 'common in Kerry Blues and Chinese Crested'?

Answer 1: No, we are not aware of the document. Liz confirmed with Dr. O'Brien, the vet school does **not** consider PNA/MSD to be a common disorder in either breed. If it were, it would be easier to solve. Liz reiterated, the vet school research dept has not published, nor distributed any updates since the CHF conference in Oct 2005.

*** I just received the CHF DVD of the presentations and the word 'common' was not used in the original presentation, slide set or the summary document. The word 'common' does appear in the summary slide set. The error lies with the CHF documentation. Gigi

Question 2: What is the status of the research? There is concern and rumor that the research is stalled or maybe stopped.

Answer 2: The research is not stalled or stopped. The isolation to the Park2 gene is the neighborhood, but there are a lot of houses to look in. Liz said she just ordered 50 more DNA test kits to look at the samples from another direction, one that has worked for other breeds. This time of year, at the school, is busy with graduation, vacations and grant submission paperwork. She will ask Dr. Johnson to give us an update we can present at the board meeting in Chicago.

Question 3: At the AKC CHF conference that

I attended in Oct 2005; Dr. O'Brien's presentation said the PNA/MSD research findings were going to be submitted to the National Institute of Health (NIH) as a grant proposal. Is there any news on that grant?

Answer 3: Liz said that they got a positive response from the NIH review committee. The research proposal was not denied, but requested further detail. This is good; Liz said most proposals are rejected on the first submittal.

*** Liz called me back; she said the NIH proposal was ranked 12th and the NIH typically grants money the top 25 proposals. They will know in June how much money they have. Gigi

Question 4: In 2004, based on what the research had found, there was talk of the vet school issuing 90 to 95% clear pedigree certificates. What is the status of that program?

Answer 4: The vet school will not be issuing any 90-95% clear certificates due to the possibility of false positive tests, which would diminish the confidence level. They would prefer to wait for a definitive DNA marker. However, they are contacting known affected sample providers, one 12 yr old male and some puppy mill dogs, for further sampling and test breeding. The vet school is aware of mills dumping Kerries. Liz said they contact the mills directly and buy affected dogs.

Factor XI Deficiency Seminar

UPDATE ON PNA RESEARCH PROJECT, JULY 2006 from Dennis

O'Brien DVM PhD, Professor of Neurology, College of Veterinary Medicine, University of Missouri

To Scott Kellogg DVM, H&G Committee Chairman:

Scott,

I thought I should give you all an update on where we are with grants and such on the PNA research.

As you probably know, we'd pretty much "hit the wall" in terms of what we could do with the financial resources we had. We know where the PNA gene is, and are pretty sure it is the PARK2 gene, but we haven't been able to

prove it. We can't develop a 100% accurate DNA test for the disease until we have the mutation responsible, so we've been kin of stymied. We submitted a grant to NIH last October to allow us to take the research to the next level and finally nail this thing. We did a preliminary study that showed virtually no dopamine in the brain of xxx, the last affected Kerry Blue we saw. NIH was very interested, since they hope to gain insight in to Parkinson's disease from all this, and we received a very good priority score in the reviews (12.7%), so I was hopeful that it would be funded. I kept waiting to get the work on the grant, but didn't hear anything until the end of June. Unfortunately, the word was that the funding cutoff was at 12%, so we barely missed the cut. I revised and re-submitted the grant for July 1 deadline, and hopefully we'll improve our score and make the cut next go around. Now we wait for the review cycle to play out again, and it will probably be April before we hear anything. Meanwhile, Dr. Johnson continues to do what he can. There was another gene right next to the PARK2 that was also a potential candidate, so Dr. Johnson sequenced that one and didn't find anything. He is looking into a different technique for finding the type of mutation we suspect is going on in the PARK2 gene, which will hopefully be easier to do than the one we were considering. We've also identified someone who can do RNA studies for us. That would allow us to prove that the PARK2 gene is really the culprit. Even though that still wouldn't give us the actual mutation, at least we would know we're barking up the right tree. Trouble is we need to collect tissues in a specific way to do that sort of study, so we have to wait for the next affected dog to come to Missouri to do so. We have found an affected Chinese Crested dog, so we're working on getting the necessary samples on that dog.

Any way, just wanted to let you know where we were at with things. Hopefully, we'll make the cut this time and be able to move forward with this. Meanwhile, if any other affected dogs surface, please let us know. Denny

United States Kerry Blue Terrier Club Judges Selection Process

The United States Kerry Blue Terrier Club (USKBTC) Judge Selection Process is the process by which USKBTC National Specialty; Sweepstakes; Futurity and Traveling Specialty conformation dog show judges are selected and subsequently contracted for a specific show date. The process includes review of previously hired judges, American Kennel Club (AKC) eligibility status, judges not approved/licensed by AKC, new breederjudges, USKBTC membership ballot distribution and tabulation, USKBTC Board of Governors (Board) role. This process also includes the role of the Selection Committee and the judge contact and contract process.

Section 1.0 The Selection Committee

1.1 Committee Purpose

The purpose of the Selection Committee is to manage the judge selection process and manage the assignments of the selected judges. The Selection Committee does not, on its own, select the judges.

1.2 Committee Members and Term

The Selection Committee consists of a minimum of four people, all USKBTC members in good standing. The Selection Committee chair person will be a Board member appointed by the USKBTC president. The Board will select/recommend the remaining Selection Committee members, who are knowledgeable breeder exhibitors, preferably one member from the east, and central, south and west regions. (See appendix 1) The Selection Committee members will serve for five years, one ballot cycle.

Guideline:

No member of the Selection Committee shall be an AKC approved judge.

1.3 Committee Role

The Selection Committee members are responsible for managing the USKBTC Judge Selection Process as stated herein. This means ensuring the ballots are distributed to the membership in a timely manner with clear instructions, setting the ballot due date, counting the ballots, creating the judges pool and reporting the results to the USKBTC Board of Governors. The Selection Committee is also responsible for maintaining the list of ineligible sweepstakes, futurity and regular class judges and adding new AKC approved breeder judges to the pool the year they are approved.

Section 2.0 Judge Eligibility

2.1 Regular Class Judge Review/Eligibility

The Selection Committee will maintain a list of judges that have been contracted for the last 10 years and the next 3 years. (See appendix 2) The names of these judges will not appear on the ballot for selection by the membership at the next ballot until the 10 years has past.

A judge will not be contracted to adjudicate the USKBTC National Standing Specialty more often than once every 10 years. A judge will not be contracted to adjudicate the USKBTC Traveling Specialty more than once every 10 years. A judge will not be contracted for the USKBTC National Standing Specialty and the Traveling Specialty with less than a 5 year period between assignments.

The USKBTC requires that its specialty judge abstain from judging our breed on Kerry Blue Terrier specialty weekends during the 12 months immediately prior to their judging assignment. Additionally, the USKBTC respectively requests that they not judge any Kerry Blue Terriers in the continental United States during the six months immediately prior to the National Specialty.

Only judges who are approved/licensed **and** appear in the AKC Judges Directory or any addendums are eligible to judge the USKBTC National Standing Specialty. Newly approved breeder-judges will be added to the pool of judges the year they are AKC approved. The Selection Committee will review the breed specific judge list as provided by the AKC for judges' eligibility. Reviews of the judges breed specific performance and capability for judging a potentially large entry should be taken into consideration.

2.2 Non AKC Approved/Licensed Judges

A person who is approved to judge Kerry Blue Terriers by an organization other than the AKC may be eligible to judge. The USKBTC will not get involved with nor assist in the AKC judge approval process. Once a non-AKC approved/licensed judge is on an AKC approved judges panel, this judge is then considered AKC approved, but will not be published in the AKC Judges Directory. A USKBTC member, in good standing, may petition the Board to include the name of a non-AKC approved judge (Continued on page 10)

on the ballot for voting by the general membership. At least three other members must endorse the judge. The ballot will note the judge is a non-AKC approved/ licensed judge. In no case shall a non-AKC approved/ licensed judge be contracted to judge the USKBTC Standing National Specialty at Montgomery County or its Each eligible member may vote for up to 30 judges from successor.

2.3 Sweepstakes and Futurity Eligibility

Only USKBTC members in good standing will be eligible to judge USKBTC Sweepstakes and Futurities. USKBTC members who have an interest in judging can express that interest on the annual dues form or in writing to the Board. The Selection Committee will vet all applicants for conformance with the requirements. The Selection Committee will classify the applicants by region and submit the names and assignments for approval by the USKBTC Board.

Judges selected for the USKBTC National and Traveling sweepstakes and Futurity may not repeat the specific assignment for a period of 5 years.

Judges selected for these assignments are not paid a fee, nor reimbursed for their expenses incurred to fulfill the assignment. These judges will be invited to attend the annual dinner and have that dinner paid for.

Guideline:

Candidates should have bred at least two litters and finished at least two champions to be eligible. Sweeps and Futurity judges should not accept Kerry judging assignments 12 months prior to the specialty assignment. Under extraordinary circumstances, these requirements may be waived by the Board, but only when no other viable candidates are available.

Section 3.0 Voting

3.1 Membership Ballot

Voting will be conducted every 5 years. Ballots will be distributed by US mail in January. The voting instructions will be included with the ballots. The list of eligible judges will be distributed to the eligible USKBTC membership. The deadline for return of ballots will be determined and ballots will be validated by the post mark on the return envelope. Any ballot that fails to meet the voting requirements will not be counted. Ballots must be originals, no photocopies will be counted.

Votes will be tabulated and sorted by number of votes received for each judge to determine the Judge's Pool order. Votes are not weighted; a simple majority determines the order. In the event of a vote tie the judges' names will be presented in alphabetical order. Judges will be contacted for availability by Judge's Pool order and subsequently contracted for the assignment. If a

iudge is not available to judge in the next three year period, the Selection Committee will move to the next name in the pool.

3.2 Ballot instructions

the list of qualified judges as provided in the ballot, no write-ins will be allowed. Breeder-judges that have been AKC approved between ballots will be added to the Judges' Pool, and then included on the next ballot. The top thirty vote getters from the membership ballots will make up the Judges Pool.

3.3 Board Ballot

The Board will only vote for Sweepstakes and Futurity assignments. Ballots by the Board for Sweepstakes and Futurity nominations will be disclosed to the Board for review and discussion.

Section 4.0 Non-regular classes

4.1 Sweeps and Futurity Judge

The Selection Committee will maintain a list of names of members that have expressed an interest in judging, or who meet the guideline for judging. Judges for these events will be selected every three years. Members that have been selected to judge will be contacted by the Selection Committee to check availability.

Guideline:

Judges will be asked not to exhibit at, or view a catalog of, the shows held the days prior to their judging assignment, i.e. do not attend or view the catalog of the Hatboro show if judging the Hatboro sweeps or the Futurity. Judges will agree not to judge a Kerry Blue Terrier sweepstakes 12 months prior to their assignment.

4.2 Futurity

Three judges, representing three of the four regions, East, Central, South and West, who meet the requirements described previously, will judge the Futurity. The fourth region will be rotated each year. International USKBTC members may be considered for this assignment with approval by the Board. International USKBTC members will be considered in the East region. Foreign breeders, non-USKBTC members, may be considered by petition to the Board.

Guideline:

Judges will agree not to judge a Kerry Blue Terrier sweepstakes 12 months prior to this assignment.

Section 5.0 Traveling and Non-Conformation Events

Blueprints

5.1 Chapter Clubs - Traveling Specialty

The USKBTC will provide the chapter club and the Traveling Specialty host club the names of the top five judges from the pool for evaluation and contracting for the Traveling Specialty. The chapter club show chair may request the list of judges that are not eligible to judge the National Specialty and Traveling, due to the 10 year rule, for use in a chapter club judge selection process. The USKBTC will, upon request from the chapter club show chair, inform the chapter club of judges, regular and nonregular classes, which have been contracted for the next 12 months, so the judges may abide by the USKBTC request not to accept assignments 6 months prior to the USKBTC specialty assignment.

The Chapter club show chair may be asked to act as the USKBTC liaison to the all-breed club for the Traveling specialty. All correspondence will be sent in writing, hardcopy or electronic, by the USKBTC corresponding secretary.

5.2 Cluster shows - Traveling Specialty

The USKBTC has no intention of paying the fees or expenses of the Traveling Specialty judge. If the host club is unwilling to accommodate the USKBTC, the liaison is authorized to spend up to \$500. In no case shall the USKBTC pay the entire fees and expenses for a judge also used by the host all breed club.

For the Traveling Specialty, the USKBTC liaison will be the Corresponding Secretary. The liaison will contact the host club and request the judge from the judges' pool, as determined by vote total, which is eligible for the assignment. The host club will be encouraged to contract this judge for breeds in addition to Kerry Blues or for Group assignments, if the judge is approved for breeds other than Kerry Blue Terriers.

If the judge is not approved for Group or other breed assignments, they may be provisional for a breed and be able to fulfill the all-breed panel provisional judge requirement. All-breed clubs are required by AKC to have at least two provisional judges on their panel. The liaison will work with the host club the Traveling Specialty is going to sit with to ensure that the judge the USKBTC membership wants is hired.

The correspondence will be conducted by the USKBTC liaison to the host kennel club's show chair and the local chapter show chair. All correspondence will be in writing, either hardcopy or electronic. The local chapter show chair may be asked to act as an agent for the USKBTC in attending meetings prior to the event.

5.3 Non-conformation events

The USKBTC board of governors will consult with a USKBTC member, in good standing, that is considered an expert in that event for advice on the selection of a

judge for that event. The event expert will act as liaison of the USKBTC for this event.

All correspondence will be sent in writing, hardcopy or electronic, by the USKBTC secretary and copied to the event expert and the event sponsor.

Section 6.0 Correspondence, Contracts, and Fees

6.1 Correspondence

The USKBTC secretary is the designated show chair for the USKBTC National and Traveling Specialty show. sweepstakes, futurity and non-conformation events unless otherwise designated by the USKBTC Board of Governors. All correspondence in regard to judges for regular and non-regular classes will be done in writing, hardcopy or electronic, by the USKBTC secretary and copied to all designated liaisons.

6.2 Contracts

All contracts will be in writing, hardcopy, with one copy for the show chair to have on hand at the event, one copy for the judge, one copy to AKC with the application and one copy for the file. Contracts will be drafted by the designated show chair/USKBTC secretary. All subsequent contact with the judges, regular or non-regular classes, regarding assignment conflicts or changes, will be conducted by the show chair/USKBTC secretary.

Guideline:


Judges under contract for the Montgomery County or USKBTC Traveling specialty will not accept another Kerry Blue Terrier specialty assignment for 12 months prior to this assignment.

6.3 Fees and Expenses

The fee for the USKBTC National Specialty, including expenses, is capped at \$500 or less depending on actual expenses. No fees or expenses are paid for Sweepstakes or Futurity judges.

The USKBTC Traveling Specialty judge fees/ expenses are to be paid by the host/all-breed club. If the USKBTC is required to compensate the judge or the host club, the fee, including expenses, is capped at \$500.

The Board of Governors will review this fee structure from time to time but no exceptions will be made without a revision of the overall fee policy in order that all judges are treated uniformly in this regard.

Stronadoa Revisited

Dear National Breed Club President;

I write this letter to inform you of a new and exciting performance event being evaluated that is designed for those large and bull terriers found in the AKC Terrier Group. This program, currently titled Strongdog, is based on historical tests accomplished in Ireland and current hunting practices found in northern Europe. As you are aware one of the uses of the larger and bull type terriers (i.e., Glens, Kerry Blues, Irish, Staffordshire Bull, and Wheaten, etc.) was the location, engagement, and extraction of large quarry, such as European Badgers, from the den or lair of the quarry.

When the American Working Terrier Association (AWTA) devised its earth dog program and then the American Kennel Club (AKC) followed suit and devised an earth dog program, many owners, breeders and fanciers that owned 'large or bull type terriers' wanted to participate in a similar earth dog program. At that time, not much was known as to the type of program that these large and bull type terriers could participate in. Many years of research and fact finding has resulted in a program being developed for these large and bull terriers and this program is based on a tried and true testing program from long ago. I have attached an informational summary of the history of the use of strongdogs and a summary of the proposed test program. We are currently finalizing the proposed test standards, and can make them available as needed.

For the past couple of years, groups on the east and west coasts have been holding fun and introductory matches for the owners, breeders, and fanciers to let them know of this program and to flush out the proposed test program standards. During this time, there have been fun and introductory matches in California, New Jersey and Connecticut. At these events we have had all of the larger and bull terrier breeds participate. Many of these owners found that this program was similar to the type of work these dogs did in historical times. We have also gotten commitments from the Glen of Imaal Terrier Club and the Staffordshire Bull Terrier Club to support this type of performance event when it goes forward to the AKC for adoption. Teastas Beag included the hunting of rats and rabbits above ground. Strongdogs, which included larger and bull type terriers such as the Glen of Imaal, Irish, Kerry Blue, Wheaten, and Staffordshire, would participate in the Teastas Mor and Misneach tests. Sounder dogs, like Welsh, Cairns, Dandies, and Fox Terriers would participate in the Teastas Beag and Mor tests.

At the Teastas Misneach trial the badger is released at the mouth of the liner and sent into the liner. If he did not hit the end of the liner, a sounder dog was sent in to encourage the badger along. A trapdoor keeper would allow the badger through to the end of the liner, but prevent the sounder dog from following. The sounder dog is then removed from the liner. The Trial then commences, as there is fresh scent, plus a badger at the end of the liner. The strongdog is released at the mouth of the liner and expected to hit the badger in under one minute. Once he reached the badger he either extracted the badger from the liner or worked the badger without any sound at all. The extraction of the badger would earn the dog the maximum amount of points. In either case, if the dog was successful in either activity, the dog was then 'certified'. Extensions for time were given if deemed necessary by the judge.

The Teastas Mor trial was similar to the Teastas Misneach trial, the liners inside dimensions are smaller (9x9 vs. 11x11) and the dogs were not expected to extract the badger from the liner. Once contact was made with the dog was required to bark or work his head off, but not attack the badger. A dog that attacked or locked on with the badger for more than one of the six minutes allocated was instantly disqualified. If the dog was successful he was then 'certified'.

The Teastas Beag trial consisted of two different types of tests, both of which were held above ground. The first of these consisted of flinging rats into a large pond and allowing a dog to swim out and hunt the rats. The inexperienced handlers of the rats created much merriment and a large proportion of the rats survived to tell the tale. In the case of the rabbits, it was released from a marked spot on the fresh ground. As soon as it had taken cover the dog was released at the spot where the rabbit had been set free. He was required to run the trail accurately and to hunt at will through briars and undergrowth. The actual catching and killing of the rabbit was immaterial as any untrained dog will often do that.

THE PROPOSED TEST

The proposed test standards that have been devised and are being evaluated are based on the historical strongdog and modern earthdog trials, held both here in North America and in Europe. However, owing to modern sensibilities there have been some changes, like the use of an animal pelt and not a live animal. The

initial standards of the proposed test are:

- Liner dimensions 11x11 inches, up to 30 feet in length. The liner can be dug into natural ground and covered or can be constructed like the liners used in current AW-TA and AKC earthdog programs, with wood sides and top and a dirt floor.
- Number and angle of turns 3 turns of either 90 or 45 degrees or a combination thereof.
- Quarry Weighted raccoon, fox, or badger hide (as compared to a live badger!!). The quarry for the test will be weighted up to 40 pounds (the size of an adult male European badger). It is likely that a lighter weight quarry will be used initially since the dogs might not be conditioned to pull the full weight.
- Scent Scenting of the liner and quarry will be accomplished before the test. Scent to be used will be raccoon, fox, or badger.
- Dog release point At liner entrance.
- Time to reach the quarry 1 minute, maximum.
- Time to bring quarry from 'den' to entrance 90 seconds , maximum.
- Extraction of quarry from liner Required for qualification. The dog's owner is required to retrieve the quarry from the dog.
- Vocalization Dogs required to be silent when working.
- Classes It is anticipated there will be at least two levels of classes, one based on a liner design like that found in the AWTA Open Class or AKC Junior Class (30', no false dens or exits), and one based on a liner design found in the AKC Senior Class (30', with false den and second entry/exit point).

The goal is to test the dog's interest in the wild quarry, their strength in pulling the weighted hide, and their determination to extract/draw the quarry out of the liner.

As these 'strongdog tests' go through the evaluation process, with different liner lengths, turns, times, type and weight of quarry, and so forth, we will be discussing this amongst the various fanciers and those participating in the test, to determine 'the best' of the different standards to included in the final test program.

Herding: An Overview

In response to the interest of the general KBT community for herding, the USKBTC formulated a committee to petition the AKC to allow the Kerry Blue to participate in AKC Herding events. The USKBTC Herding Committee is in the process of finalizing this petition for submission to the AKC this August. Based on inputs from AKC Herding judges, members of the AKC Performance Events group and delegates from the AKC Herding, Earthdog and Coursing Committee, we fully expect our efforts to succeed, and hope to be allowed to compete in AKC events beginning in 2007.

Part of our petition includes demonstrating the herding capabilities of the Kerry Blue Terrier. Fortunately there is a considerable amount of data available since the KBT has participated in a variety of herding clinics and AHBA events since 1998. An electronic survey was conducted of the USKBTC membership this past February. The survey's base consisted of 635 participants, with survey submissions by email, with subsequent interviews conducted by telephone and email.

The survey's first question, "Are you interested in participating in future herding activities", showed that 91% of the respondents answered favorably, with 9% indicating they have no interest in the sport. A subsequent question was asked of those responding favorably to determine how much, if any, activity that have had in the sport. The survey indicates that 24% of the respondents have participated in past herding events, with interests in continuing the sport.

Since a large majority of the favorable respondents had indicated they had not participated in previous herding events, subsequent inquiries were made to determine the inhibiting factor. The majority of the respondents indicated the main reason was availability. AHBA events are not available on a large scale, typically limited to specific geographic areas. From this information, it can be assumed that if Kerry Blue Terriers can participate in events held on a larger scale, as in the AKC Herding events, there will be a significant increase in the number of participants in herding activities in general by the Kerry Blue Terrier community.

"Instinct Testing" Results

The following results were obtained by reviewing the test records made available during follow up interviews to those members of the USKBTC that had indicated participation in herding instinct tests. While the results of these tests should not be used to draw a definitive conclusion on the herding abilities of the Kerry Blue Terrier, they do provide insight into the capabilities and natural instincts of the breed for the sport.

Style

- 54% used a "Gathering" Style
- 8% used a "Driving" Style
- 38% used a combination of "Gathering" and "Driving"

The two main categories for herding style include "Gathering" and "Driving". Other categories are combinations of these two groupings. A gathering dog groups the livestock and moves them to the handler or tries to hold them in one place. A driving dog moves the stock away from the handler.

During instinct testing and later training, all of the activity occurs in a small penned circle, so it may be hard to determine the dog's herding style. A gathering dog will tend to remain on the outside of the stock, holding them together whereas a driving dog will tend to fall in behind the sheep, driving the forward.

The display of a particular herding style during instinct testing should be used to determine the training program for a dog, but should not be used as a limit to the type of herding performed. A fully trained stock dog will be required to demonstrate both styles of herding for competition events.

The majority of the KBT's have shown an instinct for a gathering style. It should be noted however that a strong percentage of the KBT's tested have shown a combination style of "gathering and driving", a versatility that will prove beneficial during subsequent training and trials.

Approach

- 29% Runs "Close"
- 38% Runs "Wide"
- 33% Runs "Moderately Wide"

The "approach" used by the dog can be used to determine the dog's "balance point". This is his ability to read the sheep and control their movement. A dog that runs wide has a tendency to keep a distance

from the stock, but maintains a strong interest in the movement of the stock. To avoid later problems in controlling the stock in larger pens, a dog exhibiting this instinctive behavior should be taught to work closer to the sheep during training.

A dog that runs moderately wide varies the distance from the stock, either based on instruction from the handler, or through the dogs reading the sheep.

Running close means the dog is consistently close to the stock, perhaps to the point of "gripping". This approach can be, and should be, widened through training. Widening the dogs approach will reduce the stress on the herd and the dog. Maintaining a "comfort zone" will keep both the sheep and the dog calm, allowing the dog to maintain control of the stocks movement.

No distinguishing characteristic can be determined from the survey results at a breed level for the category of "Approach". The percentages for the three available classifications are even. It would be necessary to continue studying the breed's approach over time to determine if

there is any one general approach used by the Kerry Blue Temperament Terrier.

Eye

- 75% have a "Medium" Eye
- 25% have a "Loose Eye"
- No KBT's were classified as "Strong" Eved

The "Eye" of the dog indicates his level of concentration on the herd. The classifications for this category include "Strong", "Medium" and "Loose".

A strong eyed dog maintains a very intense focus on the stock, typically crouching down and stocking the herd. With the strong eyed dog, the handler will not be able to get the dog's attention. A strong eyed dog also has a tendency to maintain a close approach, resulting in unnecessary gripping and stress to the herd.

Fortunately, no Kerry Blues were classified as strong eyed. Our breed is predominantly medium eyed, with a small percentage classified as loose. Dogs in these classifications will demonstrate fairly free movement, typically upright, and maintain a good level of concentration on both the herd and the handler.

Wearing

- 4% demonstrated "Some Circling"
- 8% demonstrated "No Wearing" •
- 42% demonstrated "Shows Wearing"
- 46% demonstrated "A Little Wearing"

Wearing is the side-to-side movement the dog makes to keep the stock together. Some dogs will wear constantly, while other will wear in response to specific situations. A dog which shows no wearing will allow the herd to split.

In general, the test results show the breed displays a moderate level of wearing. Since it is customary to use "Velcro" sheep for herding tests, it is unknown whether the wearing style of the Kerry Blue Terrier can be determined from the results of the tests.

Bark

- 8% showed "Sustained Barking" •
- 17% showed "Some Barking"
- 17% showed "Forced Barks"
- 58% "Worked Silently"

The majority of the KBT's tested worked with the stock silently, only occasionally barking to move the stock. For Kerry Blue Terrier owners, this won't be a surprising statistic. The Kerry Blue is a very confident breed, relying on his stature and movements to control the stock and only using his voice when necessary. During early training, barking may only be a reflection of the dog's excitement that will decrease as the dog settles down to work. In cases of sustained barking, you may want to introduce a "Be Quiet" or "No Bark" command.

- 13% were "Easily Distracted"
- 29% were "A Little Distraction" •
- 58% were "Readily Adjusts •

Another credit to the confidence of the Kerry Blue can be seen in the scoring results for "Temperament". The test results indicate a large majority of the breed scored "Readily Adjusts", showing that the Kerry Blue quickly adapts to the situation, turning his attention to the job at hand of controlling the movement of the stock. The small percentage of KBT's that were recorded as "A Little Distraction" may be attributed to the fact that for many of the dogs, this was their first encounter with livestock.

Interest

- 4% showed "Some Interest"
- 38% showed "Very Keen Interest"
- 58% showed "Sustained Interest"

According to the AKC definition of the breed, "These dogs were always considered as working and sporting terriers...",

so it is no surprise that the Kerry Blue is very focused on his work. For the "Interest" category, none of the Kerrys tested exhibited "no interest" in the livestock, with the overwhelming majority showing a consistent attention to the stock.

Power

- 38% were "Forceful, Appropriate"
- 62% were "Sufficient for Stock"

• No KBT's were recorded as "Lacks Power to Move Stock"

None of the KBT's tested scored "Lacks Power to Move Stock" in the "Power" category. It should also be noted that for the test results available there were no Kerries recorded as using too much force, indicating they always remained under the control of the handler. In fact, the majority of the dogs were scored as "sufficient for stock" indicating the Kerry Blue Terriers natural ability to "read" the stock and display the necessary amount of power to control their movement.

Responsiveness

- 25% were "Somewhat Responsive"
- 75% were "Responsive to Guidance/Control"

The "Responsiveness" category judges the dog's ability and willingness to accept training and guidance. The Kerry Blue Terrier is an extremely intelligent breed with a sincere desire to please, so it follows that the vast maiority of those tested scored "Responsive to Guidance/ Control". It is also expected that those scoring "Somewhat Responsive" would improve in this category

with further training and familiarity with livestock.

Grouping of Stock

- 8% were classified as "Does Not Regroup"
- 92% were classified as "Keeps Stock Grouped/ Regroups"

From this category, "Grouping of Stock", it may be assumed the Kerry Blue Terrier is keenly focused on keeping the stock together. In fact, many of the tests included purposefully splitting the stock to test whether the KBT would regroup the herd.

Balancing Stock With Handler

- 42% were classified as "Adjusts Position"
- 58% were classified as "Some Adjustment"

This classification, "Balancing Stock With Handler", concerns the balance of the dog's movements in relation to the handler's position, not the stock's "flight zone". Since the majority of the KBT's tested were classified as "Gatherer's", it is consistent that the majority of KBT's would also be classified as "Adjusts Position", changing their position as needed to continue the movement of the stock to the handler.




Earthdog Report !





Instructions for Sample Submission

Please follow these instructions to obtain a DNA sample and remember to provide all the necessary information when you send your animal's sample. You need to send either a blood sample or cheek swabs but not both and we prefer, a blood sample. To receive swab kits, please email penngen@vet.upenn.edu number animals to be tested, name and address. If you have further questions contact us via this email or call (215) 898-3375 or (215) 898- 8894.

Blood Sample Collection (performed by a veterinary clinician or nurse)

- 1. Label one EDTA (purple top) tube with owner's last name and animal's name (or AKC#)
- 2. Take a 1-2-ml blood sample.
- 3. A blood sample must be kept cold but not frozen until shipping.
- 4. Complete required submission form and mail with sample.
- 5. Mail tube in mailer by 2-day delivery or regular service. Your veterinarian may have special Styrofoam containers or cardboard mailers to send blood tubes in a ZiplockTM bag in bubble wrap for protection.
- 6. For international shipment a customs declaration and proforma invoice must be filled out (see our website).

Cheek Swab Sample Collection

- 1. To avoid contamination with food, do not feed the animal at least three hours before you collect the sample.
- 2. Wash your hands before you collect the sample.
- 3. Label the packages that contain the cheek swab brushes with the owner's last name and the animal's name and/or AKC number.
- 4. Open the end of the swab package that shows the word, "peel," printed on it. Be careful not to touch the brush end as you remove the swab.
- 5. You may also wish to ask a second person to gently restrain the animal's head while you collect the DNA sample.
- 6. Insert brush end between the animal's gums and inside of the cheek. Roll the brush on the surface of the inside of the cheek for 15-20 seconds. Make sure that the brush is in contact with the cheek and not just with the saliva.
- 7. Return brush to its original package, allow it to dry, and then tape the opened end shut.
- 8. Repeat steps 3-5 for the second brush using opposite side of mouth. Two to three swab brushes are needed for each animal tested.
- 9. If you plan to test another animal, remember to wash your hands before you start with the next dog.
- 10. Secure brushes from each animal tested in a separate ZiplockTM bag.
- 11. The samples can be mailed by regular or express mail to address below.





	THE UNITED STAT	TES KERRY BLUE CODE OF ETHI		CLUB

This document defines the ethical standards to which we ascribe as a condition of membership in the United Stated Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

I. RESPONSIBILITIES AS A MEMBER

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a
 manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

• Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names, and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
